Questions and/or Information Request Received:

Q 1. Please provide a complete set of records documenting the failure performance of the ALMR system and sites to date. Include failure mode (equipment and failure type; hardware or software, severity level, and percentage of availability).

- A. Please see attachment titled "Information Request: ALMR Maintenance Report" published in the solicitation announcement.
- Q 2. Is Helicopter contracting and costs to be included in the Offerors responses? If so will the State supply information as to how many trips a year have been required to date (example for last three years).

A. Yes, costs are to be included in the Offerors' response. There have been 26 Flights Rd Trip in FY14, 21 Flights Rd Trip in FY15, and 18 Flights Rd Trip in FY16.

- Q 3. Are the costs the SOA pays for connectivity for Network Monitoring included in the current contract or are they contracted separately?
 - If included, please provide the band width and the cost for 2015 (not called out in the data separately)?
 - If not included, can the Bidder assume that the costs of connectivity for the Bidders proposal will also be contracted separately?
- A. Yes. Costs for connectivity for Network Monitoring are included the current contract but were not named separately. The bandwidth currently required for monitoring is one full T-1.
- Q 4. Would the State consider an additional 10 business days extension to the Proposal Due Date?
- A. The State of Alaska will allow a 10-business days extension. The new Proposals Due date is June 8, 2016. All subsequent dates in Section 2.1– Procurement Schedule will change accordingly.
- Q 5. The Evaluation Summary in paragraph 5.2 does not currently have any point allocation for the Service Plan similarly to the Risk and Value Assessment Plans. Can you please clarify if you intentionally did not include the Service Plan as part of the scoring matrix?
 - A. As part of the Best Value RFP process, the Service Plan doesn't get evaluated and scored during the Evaluation Committee review. However, the Service Plan is used as a point for discussions during the Clarification Phase with the Best Value Offeror.
