We have reviewed the attached regulations from the Board of Massage Therapists against the statutory standards of the Administrative Procedure Act. I have reviewed this project under a specific delegation dated June 14, 2016 from the Regulations Attorney. Implementing, interpreting, and making specific AS 08.61, enacted under sec. 4, ch. 114, SLA 2014, and related temporary law transition provisions under sec. 10, ch. 114, SLA 2014, the regulations refine procedures and requirements regarding continuing education for massage therapists, particularly continuing education through a regionally or nationally accredited institution of higher education.

The attached changes are Part 3 of this regulations project; 12 AAC 79.210 was originally adopted as Part 2 of the regulations, was filed April 28, 2016, and had an effective date of May 28, 2016. We find no legal problems with Part 3 of the regulations. With Part 3 we have included an original certification of adoption order, an original affidavit of board action, and related informal minutes. We have also included photocopies of other supporting documents that are filed with Part 1 of this project: regulations with an effective date of January 17, 2016 (Register 217 (April 2016)). This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations.

The June 17, 2015 public notice and the June 3, 2016 certification of adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.
