We have reviewed the attached regulations from the Department of Commerce, Community, and Economic Development against the statutory standards of the Administrative Procedure Act. I have reviewed this project under a specific delegation dated July 11, 2016 from the Regulations Attorney. The regulations add a fee for a retired nurse status license.

We find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. We request that they be filed simultaneously with a related Board of Nursing regulations update, including regulations regarding retired nurse status licenses (Department of Law file number JU2015200956 (Part 1)).

The November 21, 2015 public notice and the February 24, 2016 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

We have made some technical corrections to the regulations in accordance with AS 44.62.125, as shown on the attached copy.


