SUBJECT: Corrections to the Alaska

Assistant Attorney General Administrative Code (AAC): Authority citations following Legislation/Regulations Section--Juneau 15 AAC 151.510, 15 AAC 151.540, and 15 AAC 151.542

In accordance with the authority of the regulations attorney under AS 44.62.125(b), please forward to the publisher the corrections to the Alaska Administrative Code (AAC) described below. I have forwarded these corrections under a specific delegation dated December 1, 2015 from the regulations attorney. In the authority citations that follow three sections of 15 AAC 151, these revisions correct manifest errors in references to laws.

The authority citations to be revised follow 15 AAC 151.510, 15 AAC 151.540, and 15 AAC 151.542. The revisions to those authority citations are as follows:

--Replace the citation to "AS 18.56.340" with a citation to AS 18.56.230.

Editor's note: In sec. 3, ch. 57, SLA 2013 the legislature enacted the statute originally numbered AS 18.56.340. When codifying the session law in the Alaska Statutes, and acting under AS 01.05.031, the revisor of statutes changed the section number to AS 18.56.230. As of Register 219 (October 2016), the regulations attorney made a conforming technical revision under AS 44.62.125(b)(6), to the authority citation that follows 15 AAC 151.510, so that the original citation to AS 18.56.340 now refers to AS 18.56.230, the number assigned to the section upon codification.

These changes are necessary because the revisor of statutes, acting under AS 01.05.031, assigned a different section number, AS 18.56.230, to what was numbered AS 18.56.340 in sec. 3, ch. 57, SLA 2013. A section numbered AS 18.56.340 does not currently exist in the Alaska Statutes.
