Notice of Utility Tariff Filing

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that the Municipality of Anchorage d/b/a Municipal Light and Power (ML&P), filed tariff revision TA351-121 seeking approval of tariff revisions submitted in compliance with Ordering Paragraph 1 of Order No. U-15-097(9), issued July 15, 2016. In the ordering paragraph, the Commission required ML&P to submit revisions to Section 6.12.1 Connections to Other Systems, and Appendix A Interconnection Standards (Appendix A) of its tariff with the accepted language revisions to Sections 111 through 114, including a redline version of Appendix A showing the ordered revisions.

With TA351-121, ML&P submits revisions to Section 6.12.1 which governs ML&P's rules for allowing customers to connect to another electrical system. ML&P proposes to add the partial requirements service under Rate Schedules 770 or 780 of their tariff, and the service under Rate Schedules 28 or 29. In addition, ML&P submits revisions to Sections 111 through 114 of Appendix A, deleting language requiring installations to have the producer's non-utility generation equipment connected directly to the ML&P electric power system and deleting language requiring that installations shall not serve any of the producer's load(s) normally served by ML&P.

This notice does not contain every pertinent revision or request associated with TA351-121. The Commission may approve rates or classifications that vary from those proposed.
