(a) To be approved by the department to provide opioid use disorder treatment services, a community behavioral health services provider described in 7 AAC 70.010(a)(1)(B) or a substance abuse treatment provider described in 7 AAC 70.010(a)(2) must

(1) comply with all the requirements of 42 CFR, Part 8 adopted by reference in7 AAC 70.910;

(2) be accredited or working toward accreditation in accordance with 7 AAC 150

(3) be certified by the Substance Abuse and Mental Health Services

Administration;

(4) be registered with the Drug Enforcement Administration;

(5) meet the standards, if applicable, for drug room licensure outlined in 12 AAC 52.800 – 12 AAC 52.850;

(6) provide a comprehensive range of medical and behavioral health clinic and rehabilitative services that address addiction and addictive behavior;

(7) cooperate with the Department of Corrections to assist with opiate

withdrawal or maintenance treatment of a recipient in custody;

(8) cooperate with the attending physician and hospital staff to continue opioid treatment services upon hospitalization of a recipient; and

(9) adhere to the Substance Abuse and Mental Health Services Administration,

Federal Guidelines for Opioid Treatment Programs, adopted by reference in 7 AAC 70.910.

(b) All opioid treatment services including behavioral health clinic and rehabilitation services must be medically necessary and clinically appropriate in accordance with the

(1) The ASAM Criteria, Treatment Criteria for Addictive, Substance-Related, and Co-Occurring Conditions, adopted by reference in 7 AAC 70.910;

(2) Diagnostic and Statistical Manual of Mental Disorders, adopted by reference in 7 AAC 70.910; and

(3) International Classification of Diseases, Tenth Revision, Clinical Modification(ICD-10-CM) adopted by reference in 7 AAC 70.910.

(c) Withdrawal of services may not occur in less than 21 days. Providers shall have written withdrawal procedures for a recipient's involuntary termination of treatment services that must be explained to the recipient before imposition of the procedures.

(d) Services must be available to assure the continuity of care of each recipient. Hours of operation shall consider and accommodate recipient schedules, including but not limited to such needs as transportation, school, homemaking, employment, and child care.

(1) Services shall be made available at least six (6) days per week, 52 weeks per year, with the exception of closures on state and federal holidays as identified by the State of Alaska Department of Administration and the U.S. Office of Personnel Management. Providers shall inform the department of its published hours of operation, including scheduled closures such as holidays.

(2) Providers shall offer medication dispensing each weekday (Monday through Friday), with at least three (3) hours scheduled outside of the regular 9:00 a.m. – 5:00 p.m. business day.

(3) Medication dispensing shall be scheduled for a period of at least two (2) hours on Saturdays, if open just six days a week, and at least two hours on Sundays, if open seven days a week.

(e) In the event of an emergency leading to temporary closure of a program, an up-to-date plan for emergency administration of medications should be maintained that:

(1) Provides for the capability to respond to emergencies on a 24-hour basis; and

(2) Identifies an alternative dosing location that is secured in advance which

complies with registration requirements of the federal Drug Enforcement Administration.
