ORDER ADOPTING CHANGES TO **REGULATIONS OF THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION**

The attached one page of regulations, dealing with underground storage tank worker fees under 18 AAC 78 (Underground Storage Tanks), are adopted and certified to be a correct copy of the regulation changes that the Department of Environmental Conservation adopts under the authority of AS 46.03 and AS 46.04 after compliance with the Administrative Procedure Act (AS 44.62), specifically including notice under AS 44.62.190 and 44.62.200 and opportunity for public comment under AS 44.62.210.

We have reviewed the attached regulations from the Department of Environmental Conservation against the statutory standards of the Administrative Procedure Act. I have reviewed this project under a specific delegation dated October 26, 2016 from the Regulations Attorney. The regulations update fees regarding the certification of underground storage tank (UST) workers. Alaska Statute 46.03.375 directs the Department of Environmental Conservation to adopt regulations regarding certification, and directs the Department of Commerce, Community, and Economic Development to administer the certification program.

We find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations.
