Asking Legislature to change title 16 and update it to be more current on issuing a habitat permits. Permits on anadromous streams only make up about 50% of streams. Due to the amount of salmon streams in the anadromous streams catalog.

Discussion as to why not go through a specific legislature first, response is that the Board of Fish already has some discretionary enforcement already due to the Sustainable Salmon Policy.

Pete Zimmermen from Cook Inlet Recreation Fishermen came to speak about Proposals 19 -27 on Lower Cook Inlet king salmon saltwater troll fishery. Genetic sampling is across the board as 10000 fish have been sampled and only 2700 samples have been processed thus far.
