We have reviewed the attached regulations from the Department of Health and Social Services against the statutory standards of the Administrative Procedure Act. I have reviewed this project under a specific delegation dated January 30, 2017 from the Regulations Attorney. The regulations update the Alaska Medicaid electronic health record incentive program, in particular deleting a requirement that an attestation relating to program participation be sent in hard-copy form: a duplicative item not necessary under related federal regulations. *See generally* 42 C.F.R. Part 495 (standards for the electronic health record technology incentive program).

We find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. We note that the adoption order sets a special effective date of April 1, 2017 for these regulations.

The November 10, 2016 public notice and the December 30, 2016 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.


