





NOTICE OF PROPOSED CHANGES ON BARRIER CRIMES, CRIMINAL HISTORY CHECKS, & FIREARMS IN THE REGULATIONS OF THE DEPARTMENT OF HEALTH & SUCIAL SERVICES

The Department of Health & Social Services proposes to adopt regulation changes in Title 7 of the Alaska Administrative Code, dealing with barrier crimes, criminal history checks, and the prohibition of firearms and ammunition in certain facilities, including the following:

(1) Add facilities that will be prohibited from having firearms and ammunition on the premises, including all assisted living homes and residential psychiatric treatment centers. This prohibition already applies to assisted living homes licensed for more than five residents, and to child care centers, residential child care facilities, and maternity homes. With the proposed change, there will no longer be an exception for assisted living homes licensed for five or fewer residents.

(2) Repeal the exemption from requiring a criminal history check for relative care providers seeking to participate in the child care assistance program under 7 AAC 41. With the proposed change, those providers will be required to have a valid criminal history check as a condition for approval to participate in the program. [See 7 AAC 10.900(d)(5) and the proposed revisions to and repeals of corresponding provisions in 7 AAC 41]
