In accordance with the authority of the regulations attorney under AS 44.62.125(b), please forward to the publisher for publication in the Alaska Administrative Code (AAC) the change to the editor's note described below. I have forwarded this change under a specific delegation dated December 1, 2015 from the regulations attorney. The purpose of the change is to identify amended versions of materials previously adopted by reference.

The editor's note to be changed appears after 7 AAC 160.900. After the existing text of the editor's note, please add the following new paragraph to read as follows:

On March 1, 2017, as required by AS 44.62.245 and AS 47.05.012, the department gave notice that the following amended versions of material, previously adopted by reference in 7 AAC 160.900(a), would be in effect on January 1, 2017: the *Current Procedural Terminology*, 4th edition, as revised for 2017 ("CPT 2017") and the United States Department of Health and Human Services, Centers for Medicare and Medicaid Services' (CMS) *Healthcare Common Procedure Coding System (HCPCS) 2017*.
