## Item 1: Below are the inquiries from vendors received by DEC in writing. Following each inquiry is the DEC response.

**Inquiry 1:** Can DEC provide a list of Southeast major and minor ports?

**Response 1:** See table below:

SE Alaska	
Major Port Destination Large Cruise Vessels	Juneau (JNU) / Ketchikan (KTN) / Skagway (SKG)
Minor Port Destinations Large Cruise Vessels	Vary from year-to-year. In 2017, Haines (HNS) / Icy Straight Point (ISP) / Point Sophia (PTS) / Sitka (SIT) / Wrangell (WRG).
	Other ports used in previous years include Auke Bay (AUK) / Petersburg (PTB) / and Bartlett Cove (BCV).

**Inquiry 2:** Which Tasks in the Scope of Work does DEC want included in the bid under Constant Cost Elements: Project Reporting versus Sampling and Analyses: Analysis and Reporting? Should the Constant Cost Element: Project Reporting just include the Monthly Progress Reports?

**Response 2:** Appendix C Cost Proposal revised the name "Constant Cost Elements" to "Project Cost Elements". Project Cost Elements should include management and project costs not included in the travel, sample field collection, or analysis costs. These should not include sample analysis costs, but should include project reporting such as the monthly and Summary Report and the cost of submitting the sample data to DEC.

**Inquiry 3:** Section 5.01 states, "The Bidder shall submit Appendix D bid Schedule", should we assume you mean Appendix C?

**Response 3:** 5.01 should have correctly referred to Appendix C, not Appendix D.

**Inquiry 4:** Please clarify Note 2 in Appendix C Bid Schedule. Does group B include all of the sites in a Port or a subset of the sites in a port? Does group C include all of the sites in a port or a subset of the sites in a port?

**Response 4:** Groups B and C would be a subset of the proposed sample sites. Group B would be for two of the proposed sample sites, Group C would be for half of the sample sites. Group A sampling would occur at all of the proposed sample sites. The Bid Schedule has been modified to clarify this information.

**Inquiry 5:** Please clarify Appendix C Bid Schedule, Sampling and Analyses. The Bid Schedule asks for "Group cost per site". Does DEC want just the cost per one site in each port or the costs for all of the listed sites in each port? Would it be more accurate to state "Group costs per port"?

**Response 5:** In Appendix C Bid Schedule "Group... cost per site" will be the cost associated with sampling and analysis of the group for one site. For example, the Southeast Alaska Major Ports has 12 sites. The table entries should reflect the cost to test the respective group's analytes for 1 site.

**Inquiry 6:** Please clarify Appendix C Bid Schedule, Sampling and Analyses. For Group B costs does DEC want costs for Group B as defined under Task 1. a.vi. to include all analytes in Group A plus fecal coliforms, enterococcus, and dissolved oxygen, or just the additional costs for adding fecal coliforms, enterococcus, and dissolved oxygen?

**Response 6:** Provide the additional cost to test the subset of analytes in Group B.

**Inquiry 7:** Is DEC requesting costs for all analytes in Attachment 1 or only those included in Group A and Group B.

**Response 7:** DEC is requesting the costs of all analytes in Attachment 1.

**Inquiry 8:** Analytical costs can vary based on the required method detection limits and sample treatment for marine waters. What is the required MDL for Cu, Ni, Zn, and ammonia-N?

**Response 8:** See the table below:

Analyte	MDL	MRL	Units
Copper	0.02	0.05	μg/L
Nickel	0.02	0.05	μg/L
Zinc	0.35	0.80	μg/L
Ammonia	0.050	0.10	μg/L

**Inquiry 9:** The Bid schedule requests costs for sites/port (varying from 4 to 12). However, implementation of a QAPP will likely require additional replicate, field, and equipment blank samples. Is DEC requesting a cost for sampling 4 o 12 sampling sites, recognizing that an amendment will be required to cover costs for any additional QA samples?

**Response 9:** The cost should include duplicate samples minimum 1 per 10 and field and equipment blanks for metals.
