We have reviewed the attached regulations changes from the Board of Fisheries against the statutory standards of the Administrative Procedure Act. We find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations.

- 3. The following topic is added to the Kodiak Finfish meeting in Kodiak, January 10-13, 2017:
  - A. IN THE WESTWARD COMMERCIAL TANNER CRAB FISHERY: Consider amending the Bering Sea District Tanner crab harvest strategy (newly assigned Proposal 278 which was a board generated proposal at the 2016 Work Session, October 2016).

### Chionoecetes Crab Quick Reference Guide

The legal definitions of Tanner (C. bairdi) and snow (C. opilio) crab are in regulation 5 AAC 35.521.

A *Chionoecetes* crab with both eyes completely red in color AND with the margin of the upper mouth (also referred to as the upper teeth or epistomal margin) notched at two points with angular V-shaped cuts forming an "M" shape is, by legal definition, a Tanner crab; all others are legally snow crab.




