Administrative Code (AAC): 12 AAC 52.500(d)(3) and (4)

and Assistant Regulations Attorney Legislation/Regulations Section--Juneau

In accordance with the authority of the regulations attorney under AS 44.62.125(b), please forward to the publisher the corrections to the Alaska Administrative Code (AAC) described below. I have forwarded these corrections under a specific delegation dated December 1, 2015 from the regulations attorney. These revisions correct manifest errors.

The regulations to be revised are 12 AAC 52.500(d)(3) and (4), as filed by the Lieutenant Governor's office on June 9, 2017 to appear in Register 223 (October 2017), and with an effective date of July 9, 2017. The revisions to those paragraphs are as follows:

--In 12 AAC 52.500(d)(3), reflecting the agency's repeal of former (A) of this paragraph, I made edits to remove the superfluous "(B)" designation, because the previous version of 12 AAC 52.500(d)(3) broke out into only two subparagraphs; but those edits trigger additional conforming changes: please re-format the text that was formerly 12 AAC 52.500(d)(3)(B)(i) - (iv) so that those subsubparagraphs become subparagraphs, i.e., so that they are labeled 12 AAC 52.500(d)(3)(A) - (D) rather than 12 AAC 52.500(d)(3)(i) - (iv).

--Similarly, in 12 AAC 52.500(d)(4), reflecting the agency's repeal of former (A) of this paragraph, I made edits to remove the superfluous "(B)" designation, because the previous version of 12 AAC 52.500(d)(4) broke out into only two subparagraphs; but those edits trigger additional conforming changes: please reformat the text that was formerly 12 AAC 52.500(d)(4)(B)(i) - (v) so that those sub-subparagraphs become subparagraphs, i.e., so that they are labeled 12 AAC 52.500(d)(4)(A) - (E) rather than 12 AAC 52.500(d)(4)(i) - (v).
