#### Chapter 155. Tribal Health Programs.

7 AAC 155.020 is repealed and readopted to read:

# 7 AAC 155.020. Community health aides and practitioners, and behavioral health aides and practitioners.

- (a) The certified health provider definition will include community health aides and practitioners and behavioral health aides and practitioners.
- (b) the services of a community health aide or a community health practitioner certified by the community health aide program certification board, and the services of a behavioral health aide or behavioral health practitioner certified by the behavioral health aide program certification board, will be paid at a single statewide certified health provider encounter rate;
- (c) the certified health provider encounter rate will be calculated by the department in accordance with methodology approved by the Centers for Medicare & Medicaid Services,

  (United States Department of Health and Human Services) and included in the Alaska Medicaid State Plan. The
- (1) methodology is a cost based prospective payment rate methodology utilizing cost and encounter information from a select number of tribal providers;

(2) rates will be adjusted annually for inflation using the most recent Global Insight's Health-Care Cost Review, Skilled Nursing Facility Total Market Basket available sixty days before January 1, and rebased every four years;

(3) certified health provider encounter rate does not apply to services furnished by a behavioral health aide when delivered as part of a reimbursable service at an enrolled tribal community behavioral health clinic. The costs and encounters associated with behavioral health aide services delivered at a tribal community behavioral health clinic are excluded from the certified health provider encounter rate;

(4) payment rate under this subparagraph will not be adjusted for inflation for state fiscal year 2018.
