

Notice of Utility Tariff Filing

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Sand Point Generating, LLC (SPG) filed TA251-230, a revenue requirement study, based on a 2016 test year. With this filing, SPG requests an interim and refundable across-the-board rate increase of 15.74 percent, effective November 1, 2017, and a proposed permanent across-the-board rate increase of 39.35 percent. A selection of the current, proposed interim, and proposed permanent rates are in the table below.


