

### **Notice of Pipeline Carrier Tariff Filing**

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Kenai Beluga Pipeline, LLC (KBPL) filed TL40-668, which included Tariff Sheet No. 71 containing Tariff Schedule A. Under Section 15.6(c) of KBPL's tariff, Schedule A is to be filed annually to publish data regarding peak day high priority use provided to KBPL by interconnected utilities and High Priority End Users for the twelve months ending June 30th. TL40-668 is KBPL's annual filing of Schedule A and shows reported peak day use for the period July 1, 2016 - June 30, 2017. KBPL requested an effective date of September 15, 2017, for this compliance filing.

This notice does not contain every pertinent revision or request associated with TL40-668. The Commission may approve a rate or classification, which varies from that proposed.
