This amendment answers a question asked by a potential bidder on September 15, 2017. This amendment is for informational purposes only and need not be returned to the State.

1. **CHANGE** the Deadline for Responses (ITB Closing Date and Time) to 2:00 p.m. on Tuesday, September 26, 2017.
2. **CHANGE** the Public Bid Opening date and time to 2:15 p.m. on Tuesday, September 26, 2017.
3. **Question:** We have just purchased another helicopter that will qualify for these bids. We have all the proper op specs, insurance and capabilities to operate this helicopter as we already operate the same make and model helicopters in our fleet. It will meet all weight and equipment requirements. The new helicopter is not yet on our certificate as it is in a paint shop down south. Can I use its registration number for this bid?

**RESPONSE:** Provided the operator already owns the aircraft; has the same make and model aircraft on their current ops spec; and meet the minimum experience and all other requirements of the ITB and any amendment(s) to the ITB; the State will allow the bidder to submit a bid using the aircraft's registration number.

4. Except for the changes made in Amendments One and Two there are no further changes to the ITB as of September 18, 2017.
5. Bidders who have already submitted a bid in response to this ITB may submit a revised bid based upon information provided within this amendment. If submitted, revised bids must be received in their entirety prior to the new 2:00 p.m. on September 26, 2017 Deadline for Responses.
