

editor's note following 8 AAC
45.083

In accordance with the authority of the regulations attorney under AS 44.62.125(b), please forward to the publisher for publication in the Alaska Administrative Code (AAC) the changes to the editor's note described below. I have forwarded this change under a specific delegation dated December 1, 2015 from the regulations attorney. The purpose of the change is to identify amended versions of materials previously adopted by reference.

The editor's note to be changed appears after 8 AAC 45.083. After the existing text of the editor's note, please add the following new paragraphs to read as follows:
