In accordance with the authority of the regulations attorney under AS 44.62.125(b), please forward to the publisher for publication in the Alaska Administrative Code (AAC) the changes to the editor's notes described below. I have forwarded these changes under a specific delegation dated December 1, 2015 from the regulations attorney. The purpose of the changes is to identify amended versions of materials previously adopted by reference.


