## Notice of Utility Tariff Filing

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Sand Point Generating, LLC (SPG) filed TA255-230, proposing to update its fuel handling charge. The fuel handling charge allows SPG to recover fees imposed by an affiliate (Sand Point Services, LLC, or SPS) for costs of delivering fuel to SPG. The fuel handling charge is a cost component in SPG's fuel costs that are recovered through the COPA surcharge. With TA255-230, SPG is proposing no change to its fuel handling charge of \$0.40 per gallon. Additional information was included in TA255-230 to address the requirements set out in 3 AAC 52.507(a), which govern transactions between utilities and affiliated entities.

The fuel handling charge recovers SPS's costs related to delivering fuel to SPG and was part of the stipulation accepted with Order No. U-13-205(11)/U-13-206(10)/U-13-207(9), issued December 17, 2014. That stipulation required SPG to update the fuel handling charge with future Cost of Power Adjustment (COPA) filings; however, with Letter Order No. L1700111 the Commission required SPG to file the previous fuel handling charge as a separate filing. With TA255-230, SPG is proposing to update the fuel handling charge as a separate filing.

This notice may not contain all requested revisions and the Commission may approve a rate or classification which varies from that proposed.
