IMPORTANT NOTICE: If you downloaded this solicitation from the State's Website, you must self-register for the Plan Holders list to receive subsequent addenda. Failure to register may adversely affect your proposal. It is the Offeror's responsibility to ensure that he has received all addenda affecting this RFP.

SELECTION PROCEDURE

1. Competitive Sealed Proposals will be evaluated by a committee (2 AAC 12, Article 4). Evaluation of responses to criteria set forth in Part C results in a numerical score for each proposal. Each criterion in Part C has an assigned weight for this RFP which demonstrates its relative importance. The total of all weights is 100 (100%). Each one-percent weight equates to a range of 0-5 points per Evaluator. The maximum points (score) obtainable for any proposal is equal to the product of 500 multiplied by the number of Evaluators.
2. Scoring of proposals will be accomplished as follows:
 - 2.1 Each Evaluator will individually read and rate each Offeror's response to each criterion described in Part C - Section I - Technical Proposal. Ratings will be based solely on contents of proposal and in compliance with the Contracting Agency's standard Instructions for Evaluation Committee. Except as may be stated within any criterion description in Part C, a rating of "5" = Best Response from all Offerors; "4" to "1" = Progressively Less Responsive; "0" = Non-Responsive. Ratings are multiplied by the assigned weights for each criterion to obtain criteria scores.
 - 2.2 After completion of individual ratings in Part C, Section 1, Technical Proposal, the Evaluation Committee will meet to discuss proposals. Evaluators may then alter their ratings; however, any changes shall be based solely on the criteria set forth in Part C.
 - 2.3 After scoring Part C - Section I - Technical Proposal, criteria scores for Part C - Section II - Preferences, and Section III - Price (if applicable), will be calculated based on criteria descriptions.
 - 2.4 The total score for each Offeror will be obtained by summing the scores determined for each criterion in Sections I, II and III of Part C. The order of ranking for negotiations shall be as follows: highest scored Offeror will be ranked first, next highest scored second, and etcetera.
3. Evaluators may discuss factual knowledge of, and may investigate Offerors' and proposed Subcontractors' prior work experience and performance, including projects referenced in proposal, available written evaluations, etcetera, and may contact listed references or other persons knowledgeable of a Contractor's and/or a Subcontractor's past performance. Factors such as overall experience relative to the proposed contract, quality of work, control of cost, and ability to meet schedules may be addressed. If any issues of significant concern to the proposed contract are discovered, the Committee may:
 - 3.1 Provide written recommendations for consideration during contract negotiations;
 - 3.2 Conduct discussions in accordance with paragraph 4, below.
4. The Committee may decide to conduct discussions (or "interviews") with responsible Offerors whose proposals are determined to be reasonably susceptible of being selected for award for the purpose of clarification to assure full understanding of, and responsiveness to, the solicitation requirements (AS 36.30.240 & 2 AAC 12.290). Offerors selected by the Committee for discussions may be permitted to submit Best and Final Offers (BAFO) for final Committee Evaluation. After discussions and any BAFOs, Evaluators will determine the final scoring and ranking for contract negotiations by evaluating written and oral responses using only the criteria set forth in Part C of this RFP (2 AAC 12.260(b)).
5. All Offerors will be advised of the Offeror selected for negotiation and, after completion of negotiations, a Notice of Intent to Award will be provided to all Offerors. If contract negotiations are unsuccessful with Offeror(s) selected for negotiation, the Contracting Agency may either cancel the solicitation or negotiate with other Offerors in the order of ranking.

1. The Contracting Agency is an equal opportunity employer.
2. Copies of contract documents are available for review at the Contracting Agency's office. Offerors located outside the general vicinity of the Contracting Agency's office may telephone the Agency Contact identified on page one of this Part A for a discussion of such items.

General Conditions of the Professional Services Agreement are contained in the Small Procurement Standard Provisions Booklet, which is located on the Department's website under "Procurement."

The General Conditions are the **same** for both Competitive Sealed Proposals and Small Procurements.

3. Offerors are specifically advised that a contract shall not be in effect until a written agreement is executed by an authorized agent of the Contracting Agency. The Contracting Agency shall not be liable for any cost incurred by an Offeror in response to this solicitation, including any work done, even in good faith, prior to execution of a contract and issuance of a Notice to Proceed.

4. The Contracting Agency expressly reserves the right to waive minor informalities, negotiate changes or reject any and all proposals and to not award the proposed contract, if in its best interest. "Minor Informalities" means matters of form rather than substance which are evident from the submittal, or are insignificant matters that have a negligible effect on price, quantity, quality, delivery, or contractual conditions and can be waived or corrected without prejudice to other Offerors (2 AAC 12.990).

5. All proposals shall be open for public inspection (AS 36.30.230) after a Notice of Intent to Award is issued. Offerors should not include proprietary information in proposals if such information should not be disclosed to the public. Any language within a submittal purporting to render all or portions of a proposal confidential will be disregarded. Proprietary information which may be provided after selection for contract negotiations will be confidential if expressly agreed to by the Contracting Agency (AS 36.30.230).

6. Substitution for any personnel named in a proposal may result in termination of negotiations.

7. If it is discovered that a selected Offeror is in arrears on taxes due the State of Alaska, a contract may not be awarded until the Alaska Department of Revenue approves the payment provisions for the contract.

8. **Offerors and proposed subcontractors shall be in compliance with the statutory requirements for Alaska business licensing and professional registrations included in the certification statement on Page 2 of Part D in this RFP package.**

9. **PRICE COMPETITION:** Price cannot be an Evaluation Criterion in accordance with Article 3 of AS 36.30 for services that must be performed only by Architects, Engineers, Land Surveyors, or Landscape Architects (A/E, LS or LA) licensed in the State of Alaska, UNLESS the provisions of AS 36.30.270(d) apply; i.e., unless the services required are repetitious in nature, and the nature and amount of services required are thoroughly defined by measurable and objective standards to reasonably enable firms or persons making proposals to compete with a clear understanding and interpretation of the services required. If price is a factor, a majority of the evaluation committee must be registered in Alaska to perform architectural, engineering, or land surveying services.

- 9.1 If the services performed do not require an A/E, LS or LA, then all Offerors including any A/E, LS or LA must provide Price Proposals in accordance with AS 36.30.270(b) and 2 AAC 12.260(c).

- 9.2 Price (or any estimate of labor hours) cannot be an Evaluation Criterion for contracts that will receive Federal-aid highway program funding per 23 CFR 172.7 and FAA Airport Improvement Program funding per AC 150/5100-14E, 2.1. For FAA exceptions: see AC 150/5100/14E, 2.4.

10. An audit of the selected Offerors' and proposed Subcontractors' cost accounting systems and business records may be required to ascertain if systems are adequate for segregating contract costs; to establish a maximum allowable Indirect Cost Rate for the Agency's negotiator; and to investigate the accuracy of proposed labor rates and unit prices. In order not to unduly delay contract negotiation or award, be prepared to submit Pre-Audit Statement, DOT&PF Form 25A257 immediately for your firm and any subcontract that may exceed \$250,000.

For contract amounts less than \$250,000, the Contracting Agency may require the Offeror and proposed Subcontractor to submit the Pre-Audit Statement if deemed necessary to determine allowable costs under Title 23 CFR requirements. If selected for negotiation, failure to submit properly completed Pre-Audit Statement(s) in a timely manner may disqualify an Offeror from further consideration. Information from Pre-Audit Statements and any Audit conducted for the Contracting Agency is considered proprietary and will be confidential.

11. Standard insurance provisions for Worker's Compensation, General and Automobile Liability, and Professional Liability are contained in DOT&PF Form 25A269, Indemnification and Insurance. Coverages may be modified under very limited circumstances. Offeror should not assume any modification of coverages.

12. Professional Liability Insurance for the proposed contract: is not required

13. The proposed contract will will not be a Federally Assisted Program of the U.S. Department of Transportation. If it will be an assisted program, then the Offeror shall insert the following notification in all subcontract solicitations for bids or proposals pertinent to this RFP:

SECTION I - TECHNICAL PROPOSAL

1. Objectives and Services

1. Weight: 20

Response must **demonstrate your comprehension of the objectives and services** for the proposed contract. Do not merely duplicate the Statement of Services provided with this RFP. Also, consider if Statement of Services is sufficiently explicit; are expressed or implied schedules attainable/economically feasible; etcetera? Explain. **Define any assumptions made** in formulating Criteria Response. If design services for a construction project are included, express any opinions regarding alternative design considerations that could impact construction costs.

2. Methods

2. Weight: 25

Response must outline the methods for accomplishing the proposed contract or, if methodology is contained in the proposed Statement of Services, address its adequacy. Describe what, when, where, how, and in what sequence the work will be done. Address how proximity to the Project site, *particular* geographic familiarity, experience, and capabilities of your firms (Offeror and Proposed Subcontractors) and Project Staff might *specifically* contribute to the proposed methods.¹ Identify the amount and type of work to be performed by any Subcontractors. Consider how each task may be carried out; what services or interaction required from/with the Contracting Agency; etcetera. Suggest alternatives, if appropriate. Identify any **distinct and substantive qualifications** for undertaking the proposed contract such as the availability of specialized equipment or unique approaches or concepts **relevant to the required services** which the firms may use.

3. Management

3. Weight: 5

Response must describe the administrative and operational structures that will be used for performing the proposed contract. For example consider: who will have overall responsibility for the contract? Who will have direct responsibility for specific disciplines? What will the lines of authority be? For any individual who would be in "responsible-charge" (reference AS 08.48) as an Architect, Engineer, Land Surveyor or Landscape Architect, so state and list his/her Alaska professional registration number. A graphic depiction is preferred in your response to this criterion. Additionally, the Contracting Agency may want to inspect work products in progress and have a close ongoing working relationship with your Project Staff. Accordingly, your response should also identify where the various contract services will be performed, *in proximity to the Contracting Agency's office* ², and how communications will be maintained between your Project Staff, the Contracting Agency, and (as applicable) any other government agencies or the public.

4. Proposed Project Staff

4. Weight: 20

Response must name the individuals to perform the following **FUNCTIONS** plus any other professional/technical functions you deem essential to perform the services:

1. Contract Management (contract compliance)
2. Project Manager/Sr. Geotechnical Engineer or Sr. Geologist (single point-of-contact directly engaged in contract performance.
3. Field (Staff) Geologist/Field (Staff) Engineer
4. Staff Geotechnical Engineer

*All personnel acting in responsible charge for all Architectural, Engineering, Land Surveying, and Landscape Architecture functions require an Alaska Registration and must be identified in your proposal.

¹ Delete sentence beginning with "Address how proximity. ..." if any federal funds unless performed by licensed Architects, Engineers or Land Surveyors.

² Delete sentence beginning with "Accordingly, your response..." if any federal funds unless performed by licensed Architects, Engineers or Land Surveyors.

Describe the work to be performed by the individuals you name to perform essential functions and detail their specific qualifications and substantive **experience directly related to the proposed contract**. A response prepared specifically for this proposal is required. Marketing resumes often include non-relevant information which may detract from the evaluation of proposal. Lists of projects are not useful. Focus on individual's specific duties and responsibilities and how project experience is relevant to the proposed contract.

For each person named, identify their: employer, professional discipline or job classification and state of residency. List at least 3 professional references (contact persons and telephone numbers) for each person.

5. Workload and Resources

5. Weight: 5

Response must: (1) discuss both current and potential time commitments of your proposed Project Staff to all clients; (2) discuss the projected workload of each firm (Offeror and Proposed Subcontractors) for all clients; and (3) demonstrate adequate support personnel, facilities and other resources to provide the services required. Provide a list of current contracts with the Contracting Agency in which your proposed Project Staff are participating. Include all contracts statewide with regions, divisions, etc., of the Contracting Agency.

Briefly address capabilities for providing additional services and/or services under an accelerated schedule. Address capacity to reassign personnel, equipment and facilities whenever the proposed contract would not require such capabilities or was delayed.

6. Past Performance & Quality Control

6. Weight: 20

Response must describe previous projects the project team has worked on that are related in size and scope to this project. Describe the dollar amount of the projects and a brief narrative of the successes of the projects. Address how the experience will help your team to perform under this contract. Provide references (contact name and phone number) for each project. Indicate which of the proposed firms and project staff was involved in each project. The State reserves the right to investigate referenced projects, contact references and research other projects that the respondent has worked on.

Include in your response a description of your firm's quality control process and how this process has affected the quality of your deliverables. Use specific examples.

7. Quality of Proposal

7. Weight: 5

Offerors do not respond to this criterion. Committee members will rate this criterion based on their perception of the clarity, completeness and presentation of submittal. Note: This criterion is **NOT** used to evaluate color, graphics or other visual techniques except as they may detract from legibility.

- (B) Proposal is submitted under the name as appearing on the Firm's current Alaska Business License;
- (C) Firm has maintained a place of business within Alaska, staffed by the Firm or an employee of the Firm, for a period of six months immediately preceding the date of the offer;

Alaska Bidder (Offeror) Preference will be scored: Rating x Number of Evaluators x Weight = Criterion Score.

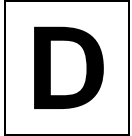

CONTRACTOR shall include the provisions of this form in all subcontracts that exceed \$25,000 and shall ensure Subcontractor's compliance with such provisions.

ARTICLE D1 INDEMNIFICATION

D1.1 The CONTRACTOR shall indemnify, hold harmless, and defend the CONTRACTING AGENCY from and against any claim of, or liability for negligent acts, errors or omissions of the CONTRACTOR under this Agreement. The CONTRACTOR shall not be required to indemnify the CONTRACTING AGENCY for a claim of, or liability for, the independent negligence of the CONTRACTING AGENCY. If there is a claim of, or liability for, the joint negligent error or omission of the CONTRACTOR and the independent negligence of the CONTRACTING AGENCY, the indemnification and hold harmless obligation shall be apportioned on a comparative fault basis. "CONTRACTOR" and "CONTRACTING AGENCY", as used within this article, include the employees, agents and other contractors who are directly responsible, respectively, to each. The term "Independent Negligence" is negligence other than in the CONTRACTING AGENCY's selection, administration, monitoring, or controlling of the CONTRACTOR and in approving or accepting the CONTRACTOR's Work.

D1.2 The CONTRACTOR shall exercise that degree of skill, care and judgment commensurate with the professional standards for the services of a similar nature. When such standards are in dispute, they shall be established by a panel of three qualified, impartial professionals objectively selected and appointed by the Appeals Officer.

D1.3 The CONTRACTOR shall correct, through re-performance at its expense, any services which are deficient or defective because of the CONTRACTOR's failure to perform said services in accordance with professional standards, provided the CONTRACTING AGENCY has notified the CONTRACTOR in writing within a reasonable time, not to exceed 60 days, of the discovery of any such deficiency during the performance of the services and within 12 months of the date of final payment under this Agreement.

ARTICLE D2 INSURANCE

D2.1 Without limiting the CONTRACTOR's indemnification, it is agreed that CONTRACTOR shall purchase at its own expense and maintain in force at all times for the duration of this Agreement, plus one year

following the date of final payment, the following policies of insurance. Where specific limits are shown, it is understood that they shall be the minimum acceptable limits. If the CONTRACTOR's policy contains higher limits, the CONTRACTING AGENCY shall be entitled to coverage to the extent of such higher limits. Certificates of insurance must be furnished to the CONTRACTING AGENCY and incorporated into this Agreement with copies attached to this document. Certificates must provide for the CONTRACTING AGENCY to receive notice of any policy cancellation or reduction per AS 21.36 Sections 210-310. Failure to furnish certificates of insurance or lapse of the policy is a material breach and grounds for termination of the CONTRACTOR's services and may preclude other Agreements between the CONTRACTOR and the CONTRACTING AGENCY.

D2.1.1 Worker's Compensation Insurance: The CONTRACTOR shall provide and maintain, for all employees engaged in work under this Agreement, coverage as required by AS 23.30.045, and; where applicable, any other statutory obligations including but not limited to Federal USL&H and Jones Act requirements. The policy(s) must waive subrogation against the State of Alaska.

D2.1.2 Commercial General Liability Insurance: Such policy shall have *minimum* coverage limits of \$300,000 combined single limit per occurrence, covering all business premises and operations used by the Contractor in the performance of services under this agreement. The policy shall be written on an "occurrence" form and shall not be written as a "claims-made" form unless specifically reviewed and agreed to by the CONTRACTING AGENCY.

D2.1.3 Comprehensive Automobile Liability Insurance: Such policy shall have *minimum* coverage of \$300,000 combined single limit per occurrence covering all vehicles used by the Contractor in the performance of services under this agreement.

D2.1.4 Professional Liability (E&O) Insurance: Covering all negligent errors or omissions, and negligent acts, which the CONTRACTOR, Subcontractor or anyone directly or indirectly employed by them, make in the performance of this Agreement which result in financial loss to the State of Alaska. Limits required are per the following schedule:

**ARTICLE D3
MODIFICATION OF INSURANCE REQUIREMENTS**

CONTRACTOR RELATED MODIFICATIONS

- D3.1 **Workers Compensation Insurance** is not required because the CONTRACTOR is an Independent Contractor, Sole Proprietor or Self-Employed Person having no employees in any sense of AS 23.30.045.

- D3.4 **Professional Liability (E&O) Insurance** is not required because: 1) the CONTRACTING AGENCY's use of the services or Work products obtained from the CONTRACTOR will not result in significant exposure to any third party claims for loss or damage; and 2), the CONTRACTOR services will not apply to any construction, alteration, demolition, repair or direct use of any highway, airport, harbor, building or other structure.
- D3.5 **Professional Liability (E&O) Insurance** is not required because this Agreement is for one of the following applicable (*checked*) services for which E&O coverage is not needed:
 - Right-of-Way Fee Appraisals
 - Photogrammetric Mapping Services
 - Architectural/Engineering review of Construction Bid Documents wherein design responsibility clearly remains with the designer of record.

**Klawock Airport Taxiway Construction, Taxiway A and Apron Pavement Rehab
Project No. SFAPT00121**

Project Scope

Refer to Attachment 1, Scoping Exhibit, to see the color coded Work Items for this project.

Work Item 1: Construct new taxiway (Taxiway “B”) at the north east end of the existing runway. Construct new parallel taxiway (Taxiway “A”) between the existing apron and the new Taxiway “B”. Construct new taxilane (Taxilane “F”) 90 degrees to Taxiway “A” to an area designated for future lease lot development on the east side of the runway. The proposed taxiways and taxilane will be constructed on earthen embankments with 35’ paved surface and 79’ Safety Area width and include lighting and signs.

Work Item 2: Rehabilitate the existing apron. Construct thickened pavement structure on a portion of the existing apron for parking of heavier planes than the apron is currently designed for. This project will also install new aircraft tie downs on the existing apron.

Work Item 3: Drainage structures will be constructed under the taxiways to maintain the existing ground surface runoff patterns.

Work Item 4: Construct new public parking area using excess excavation from obstruction removal.

Work Items 5, 6, 8, 10, 12, 13: Items that may or may not require any geotechnical investigation include relocating the FAA building, new airfield power system, relocating the wind cone, utility relocates, waste disposal areas (unless containment berms are required), and constructing perimeter fencing.

Work Item 7: Construct access road to potential on-site material source. Construct road to ultimately serve as an extended parallel taxiway per Work Item 1. For this project the embankment would be constructed to bottom of subbase.

Work Item 9: Remove existing embankment.

Work Item 11: Construct staging area in location of future lease lot development.

Work Item 14: The embankments are proposed to use excavation taken from airspace obstruction areas

Proposal Requirements and Emphasis for Selection

In addition to the requirements specified in the Part C- Evaluation Criteria, the Consultant's proposal will be reviewed specifically for the elements listed below. Emphasis will be placed on these elements for selection of the winning proposal. The Consultant is not expected to have first-hand knowledge of the site but should provide a general discussion based on the Scoping Exhibit (Attachment 1), Scoping Plans (Attachment 2), site photos, and available internet aerial imagery. All final plans, scope of work, deliverables, and schedules will be negotiated upon award of the contract and it is understood that the details and dates included in the Consultant's response to the RFP are generalizations and approximations. The elements emphasized for selection include:

1. Demonstrated comprehension of the project scope
 - If sufficient detail is lacking in the current project scope provided by DOT&PF, identify elements for additional consideration or clarification.
2. Proposed geotechnical investigation methods
 - The REG is looking for effective and efficient data collection. Each exploration method and point should collect *all* the data required but *only* the data required.
 - Include exploration methods, sampling methods and frequency, and lab testing methods and frequency and any other pertinent detail.
3. Proposed format of the Geotechnical Data Report
 - The REG will provide a report template to be used as a starting point for the GDR deliverable. The template is not ideally suited for the project needs and the REG expects the Consultant to make all necessary changes.
 - The Consultant should discuss, describe, or demonstrate how they will make the GDR clear, concise, and user friendly.
 - The Consultant should demonstrate an understanding of how and why the collected data is presented in the Geotechnical Data Report.
 - The REG expects the Consultant's response to this RFP will demonstrate examples of clear, concise, user friendly report writing and data presentation.
4. Description of all possible geotechnical elements anticipated and what data will be collected during the field investigation to address them.
5. Proposed schedule for execution of Task 3 through Task 6 as detailed below. The schedule can be used in place of the Current and Projected Workload Summary discussed in the Part B- Proposal Form.
6. Relevant experience of the Consultant's field personnel and project manager working with the Southcoast REG. Consultant's with no prior experience are asked to provide a plan to develop good communication with the REG, and understanding of the REG's expectations for performance. If the Consultant's field personnel and project manager have direct experience working with the Southcoast REG a simple list of those projects may be substituted for the 'related work experience' paragraph required in the Part B- Proposal Form. List only projects or experience for the staff that will be primarily responsible for the execution of this contract. General experience of a Consultant's firm may not be included.

General Requirements

1. Follow the *Alaska Geotechnical Procedures Manual*, and the *FAA Advisory Circular 150/5320-6F*.

2. All work will be authorized under a single Notice To Proceed.
 3. DOT&PF will provide most necessary permits and authorizations for the geotechnical design investigation detailed in the Exploration Plan. Some permits may take up to 30 days to obtain. *The Consultant will be responsible for any required FAA permits.*
 4. Traffic control plans (TCP) are not anticipated to be required for this project. If the final scope includes work that does require a TCP the Consultant will be responsible for submitting it to the Regional Engineering Geologist for approval at least 5 business days prior to mobilization. The TCP must meet all the requirements of the Alaska Traffic Control Manual and be approved prior to commencement of work.
 5. All required drilling and traffic control services will be obtained by the Consultant.
 6. All borings in paved surfaces must include this minimum data:
 - a. record the pavement thickness to the nearest ¼ of an inch
 - b. obtain a continuous sample of the base course for laboratory analysis
 - c. obtain a continuous sample of the subbase for laboratory analysis to a depth of at least 24 inches below the top of pavement.
 7. The Consultant is expected to obtain sufficient data to derive pavement structural section characteristics to be used for the purposes of pavement design. The Consultant is expected to describe the means in which the data will be collected and describe the method in which the data can be used to derive pavement strength characteristics (e.g. resilient moduli and Poisson's ratio).
 8. All boring logs will be generated using the DOT&PF provided gINT template.
 9. Contact the Regional Engineering Geologist Mitch McDonald prior to commencement of drilling for the exact block of point ID's assigned to this contract. Use the following convention for numbering all subsurface data points:

Tasks

1. **Site Visit and Exploration Plan.** DOT&PF will provide a scoping plan and draft plan and profile drawings (Attachment 1, 2) for the consultant to review prior to the site visit.
 - a. Conduct a 1 day site recon to aid in preparing an exploration plan.
 - b. Scoping Meeting: Immediately after the site visit but before submitting the exploration plan, The Consultant will:
 - i. Conduct a 2-4 hour meeting at the DOT Juneau office with the REG and DOT project design team. It is expected this meeting will occur while the Consultant is in travel status on the return from Klawock. The purpose is to:
 1. Discuss the findings from the site visit (Task 1)
 2. Review the project scope with the Project Manager
 3. If required, modify the scope of services within the limits of the contract
 - ii. The Consultant will provide a meeting agenda and take meeting notes to be distributed, reviewed by DOT, and finalized after addressing any comments. Allow 2 days for review of meeting notes.
 - c. Submit an exploration plan and list of all Consultant personnel and subconsultants that will be on site.
 - d. Schedule for all tasks. The REG prefers schedules developed with Microsoft Project but this is not a requirement.
2. **Geotechnical Field Investigation.** Conduct the field investigation after all environmental permits, property access authorizations, any required FAA approvals, and approval of the exploration plan are obtained.
 - a. Complete all field work identified in the exploration plan.
 - b. Complete any additional field work that is approved by DOT&PF. This work might be identified by the consultant during the originally planned field investigation or by DOT&PF at any time during the execution of this contract.
 - c. Provide the REG with an exact copy of the field personnel's field map for reference during the investigation. Email daily reports to the REG. Include a list of borings completed that day, any notable discoveries or changes in the subsurface conditions, proposed changes to the exploration plan, and any drilling issues in the daily report. Additional information may include photos of drill logs.
3. **Geology Data Report (GDR).** An example of the required GDR format is provided as Attachment 3. Electronic files will be made available upon award of the contract for the Consultant's use. Prepare boring logs with the provided gINT library and template files included as Attachment 4.
 - a. Geotechnical Review Meeting
 - i. Prepare handouts that include key figures for the GDR such as the boring location map, peat probe location/refusal depth map, and surficial geologic maps. Provide electronic copies of site photos and if available at the time of the meeting, any data graphs or tables that will be in the GDR.

- ii. Conduct a 2-4 hour Geotechnical Review Meeting at the DOT office in Juneau with the project design team to summarize the findings and identify items to include in the Geotechnical Memo (GM). The meeting should be held sometime after the field investigation but before finalizing the comments from the draft GDR review. Depending on project complexity and design schedule coordinate with the REG to identify the best time to schedule the meeting.
 - iii. The Consultant will provide a meeting agenda and take meeting notes to be distributed, reviewed by DOT, and finalized after addressing any comments. Allow 2 days for review of meeting notes.
- b. Draft GDR
- i. The GDR template provided is not ideal for this investigation and the Consultant is expected to modify it as necessary. Use the template to establish report elements such as cover page layout, fonts, organization, figure layout, table formats, cover and signature sheets, etc.
 - ii. Submit the draft GDR to the REG for review and comment. Allow a minimum of 15 work days for review.
- c. Final GDR
- i. Submit the final GDR incorporating review comments from DOT&PF. Include 3 signed hard copies and an electronic copy.
 - ii. Submit the provided subsurface matrix (Attachment 5) as an excel spreadsheet, all ArcGIS files, all gINT files, all photos, and all other electronic files used to complete the GDR.

4. Project Meetings

- a. Bi-weekly meetings
- i. After the Geotechnical Review Meeting schedule and conduct bi-weekly progress meetings via phone to keep the REG informed of project development. Each meeting would take approximately 30 minutes and cover schedule, invoicing, and active work tasks.
 - ii. Only Consultant personnel actively involved in project related tasks are expected to participate.
 - iii. Take meeting notes using the provided template (Attachment 6) for all scheduled meetings. After each scheduled meeting distribute draft notes to all participants and allow 2 business days for review. Address all comments and provide a final copy of the notes to all participants.
 - iv. Meetings are anticipated to continue relatively uninterrupted until the draft GM is submitted. This is a flexible task item and will be adjusted to fit the project needs and activity levels.

5. Geotechnical Recommendations Memo (GM). The GM may be formatted, with the approval of the REG, in the way most convenient for the Consultant.

- a. The GM should include all items identified in the Geotechnical Review Meeting. Currently recommendations are anticipated for:

- i. Excavation and backfill requirements for the new taxiway, lease lot access road, and any other newly constructed haul routes.
 - ii. Geotechnical analysis for construction of embankment partially bearing on a constructed wood waste fill.
 - iii. Foundation recommendations for the new wind cone if required.
 - iv. Any obstructions the 10 foot deep grounding rods may encounter for any proposed lighting upgrades.
 - v. Anchor design for aircraft tie downs if required.
 - vi. Development and suitability of proposed material sites.
 - vii. Perimeter fence post foundations in soft, soils.
 - viii. Any data interpretation that may be helpful for project designers.
 - b. Draft GM
 - i. Submit the draft GM to the REG and the Project Manager and allow a minimum of 15 working days to review.
 - c. GM Review Meeting
 - i. Plan and conduct a 1-2 hour meeting to discuss recommendations with the design team to ensure they are clearly understood.
 - ii. This meeting may either be in person at the Juneau office or via phone and will be determined after the draft GM is reviewed.
 - iii. The Consultant will provide a meeting agenda and take meeting notes to be distributed, reviewed by DOT, and finalized after addressing any comments. Allow 2 days for review of meeting notes.
 - d. Final GM
 - i. Submit the final GM incorporating review comments from DOT&PF. Include 3 signed hard copies and an electronic copy.
 - ii. Submit any calculation packages and all other electronic files used to complete the GM.
- 6. Pavement Recommendations Memo (PRM).** Prepare a PRM using the guidance from AC 150/5320-6F.
- a. Recommendations are anticipated for the apron rehabilitation, proposed new taxiway, and access road to the aviation leasing area. Analysis of additional pavement sections may be requested.
 - b. Aircraft fleet mix and air traffic growth forecasts can be found in the Klawock Master Plan.
 - c. Annual Commercial Operation data can be found at [the USDOT Bureau of Transportation Statistics website](#) and used to help determine annual departures.
 - d. Evaluate the seasonal frost impacts per section 2.7 of the AC and determine how seasonal frost design compares to the design requirements of the fleet mix.
 - e. Submit a draft PRM to Regional Engineering Geologist and the Project Manager for review and comment. Allow a minimum of 15 work days for review.
 - f. PRM Review Meeting

- i. Plan and conduct a 2-3 hour meeting to discuss recommendations with the outcome being a preferred pavement section or request to analyze additional alternatives. Key DOT&PF personnel include the REG, Reg Materials Engineer, Design Project Manager, Project Designer, Construction Manager, and Construction Project Engineer.
 - ii. This meeting will be in person at the Juneau office.
 - iii. The Consultant will provide a meeting agenda and take meeting notes to be distributed, reviewed by DOT, and finalized after addressing any comments. Allow 2 days for review of meeting notes.
 - g. Final PRM
 - i. Submit the final PRM incorporating comments from the PRM review meeting.
- 7. **Plan Review.** To insure all recommendations are correctly incorporated into the project plans and specifications the consultant will participate in a review and is expected to provide any necessary comments in a spreadsheet provided by DOT at the time of the review.

 - ii. Review meeting at Juneau 7 Mile office if required
 - b. PS&E
