This amendment addresses questions asked by potential bidders as of June 25, 2018. This amendment is for informational purposes only and need not be returned to the State.

1. Question: Application of said three products on ITB #180000073 will be done by whom?

**Response:** State, federal, local government, or contracted staff of contracts issued separately from the contract resulting from this ITB.

2. **Question:** Being this is an as needed basis ITB will delivery be stated wherever in Alaska the product is to be used with thirty days of award, and or will award winner be required to have product available for the duration of the contract on an as needed basis?

**Response:** Orders will be placed against the contract on an as-needed basis only. Delivery location will be specified within the State's order and will be anywhere within the State of Alaska. The state does not require the contractor to maintain product in stock for the duration of the contract. Should the contractor choose to maintain product in stock it will be at their sole discretion and expense.

3. **Question:** Can you provide additional information / define what "Prescription Recommendations & Consultation" under item B, bid cost for additional services?

**Response:** We rely on herbicide experts to provide expertise and experience in herbicide prescriptions (how much, how often, and when to apply herbicides) for waterbodies in Alaska. Each water body is unique in its character, flow, and natural dynamics, as well as the level of infestation of invasive plants.

4. **Question:** Also under B, bid cost for additional services, "GIS Support", is it acceptable for our company to provide this service through subcontracting?

**Response:** Subcontracting for GIS support only is acceptable; subcontracting is not allowed for Prescription Recommendations and Consultation and On-Site Application Assessment. The prime contractor will be solely responsible for the satisfactory performance of the subcontractor and subcontracted services and for the compensation of the subcontractor. Subcontractor costs for GIS support will only be paid at the hourly rate for this service in the accepted bid without any additional contractor mark-ups, fees, charges, or other costs.
