The Department of Law has reviewed the attached regulations of the Department of Commerce, Community, and Economic Development against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations concern biennial licensing fees for audiologists, speech pathologists, and hearing aid dealers. The agency requests that the regulations be filed in time to be in effective by August 15, 2018 or sooner in time to become effective for upcoming license renewal.

The regulations were adopted by the Department after close of the public comment period. The public notice and the adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

We have made a minor technical correction to conform the regulations in accordance with AS 44.62.125.

BRIEF DESCRIPTION: The Department of Commerce, Community, and Economic Development proposes to change occupational license fees charged to audiologists, hearing aid dealers, speech-language pathologists, and speech-language pathologist assistants.

The Department of Commerce, Community, and Economic Development (Department) proposes to adopt regulation changes in Title 12, Chapter 02 of the Alaska Administrative Code including the following:

12 AAC 02.130. Audiologists, hearing aid dealers, speech-language pathologists, and speech-language pathologist assistants, is proposed to be changed to alter the application, license, registration, renewal, and temporary license fees for audiologists, hearing aid dealers, speech-language pathologists, and speech-language pathologist assistants.

Under AS 08.01.065, the Department must establish fee levels so that the total amount of fees collected for an occupation approximately equals the actual regulatory costs for the occupation. The Department has reviewed the income and expenses for the occupational licensing programs mentioned above and proposes fee changes that reflect, to the extent possible, the actual costs of the activities under these occupational licensing programs.

You may comment on the proposed regulation changes, including the potential costs to private persons of complying with the proposed changes, by submitting written comments to Sher Zinn, Regulations Specialist, Division of Corporations, Business and Professional Licensing, P.O. Box 110806, Juneau, AK 99811-0806. Additionally, the Department will accept comments by facsimile at (907) 465-2974 and by electronic mail at RegulationsAndPublicComment@alaska.gov. The comments must be received not later than 5:00 p.m. on June 20, 2018. Comments received after this deadline will not be considered by the Department.




