WORKERS' COMPENSATION THIRD PARTY ADMINISTRATOR RFP 2019-0200-4001 Amendment #3 Issued July 19, 2018

Note: it is the proposer's responsibility to review and accept all amendments to this solicitation.

- This amendment lists questions submitted by potential bidders as of July 13th, 2018; and answers to questions to be included and make part of RFP 2019-0200-4001 Workers' Compensation Third Party Administrator.
- 2. This amendment addresses changes to the following sections:
 - a. SEC 4.06 Experience and Qualifications
 - b. SEC 4.08 Cost Proposal
 - Attachment B Cost Proposal, Amendment 3.
 Offerors must use the amendment 3 cost proposal when submitting their proposals or may be found non-responsive.

Amendment to Section 4.06 Experience and Qualifications

Offerors must provide 3 written references, on form provided as attachment H, for similar projects the offeror's firm has completed.

Offerors must provide an organizational chart specific to the personnel assigned to accomplish the work called for in this RFP; illustrate the lines of authority; designate the individual responsible and accountable for the completion of each component and deliverable of the RFP.

Offerors must provide a narrative description of the organization of the project team and a personnel roster that identifies each person who will actually work on the contract and provide the following information about each person listed:

- title,
- resume,
- location(s) where work will be performed,

• itemize the total cost and the number of estimated hours for each individual named above.

Amendment to Section 4.08 Cost Proposal

Cost proposals must include an itemized list of all direct and indirect costs associated with the performance of the contract, including, but not limited to, total number of hours at various hourly rates, direct expenses, payroll, supplies, overhead assigned to each person working on the project, percentage of each person's time devoted to the project, and profit. Cost proposals must include an all-inclusive fee to perform all services required in this RFP. The annual assessment must be an all-inclusive total to be charged per month and calculated for the amount to be charged annually.

Question and Answer Log Amendment 3:

1. Question: Will the State be responsible for mandatory EDI reporting to the Alaska Department of Labor (DOL)? In that same context, what are the State's current protocols/processes for insuring compliance with DOL requirements?

Answer: The State is currently reporting on paper to ADOL. The current TPA is being trained on the EDI reporting process through use of our claims system (Origami/Mitchell) with anticipated go live to ADOL by August 1, 2018. We are implementing Claims Release 3.0 reporting standards adopted by the IAIABC. The State receives announcements for ADOL reporting requirement updates or changes and will ensure any edits to reporting standards are implemented by EDI Sender/claims system.

2. Question: Is an EDI interface currently in place between the Origami system and DOL?

Answer: Yes, EDI interface is currently in place between Origami/Mitchell and ADOL.

3. Question: EDI Live status; When is the SOA expected to go live with EDI reporting?

Answer: Current EDI go live for EDI reporting is anticipated by August 1, 2018.

4. Question: Will EDI generate from Origami or filter through a 3rd party vendor? If 3rd party, who is vendor?

Answer: EDI generates through Origami by Mitchell.

5. Question: Will adjuster be able to control what type of SROI report will be sent to ADOL or will system data/3rd party make this determination?

Answer: Adjuster controls the type of SROI report submitted to ADOL.

- **6. Questions:** Please provide statistics with respect to the following 2017 managed care outcomes:
 - a. How many medical provider bills were processed?
 - b. What was the percentage of savings achieved on these same bills when repriced to the Alaska fee schedule?
 - c. What was the percentage of savings achieved on these same bills when PPO discounts were applied?
 - d. Please provide insight into the State's current PBM pricing model with the incumbent provider.

Answers: Data was not provided by previous MBR vendor. The following answers are for bills processed by Equian between June 2017 and December 2017, which occurred during transition.

- a. Equian processed 4,967 bills through MBR.
- b. Equian saved 47.5% on these same bills when repriced to the Alaska Fee Schedule.
- c. Proprietary information
- d. Proprietary information
- **7. Question:** What network(s) comprise Equian's Alaska network?

Answer: Equian's network(s) are proprietary information.

8. Question: What pharmacy benefits management (PBM) vendor does the State currently contract with?

Answer: The current vendor for PBM is Equian.

9. Question: Please provide additional insight into the State's loss fund/banking process. In particular, we understand that the State makes all claims and allocated loss expense payments. How are these costs posted to the respective claim files? Does the State use State personnel to for these tasks, or does the incumbent TPA manage the process? If the latter how often does the State provide the incumbent TPA with the required statistical data?

Answer: TPA staff is required to attach, review, and enter all payments (time loss, medical, ALAE expenses, etc.) and penalties to the specific claim within Origami. TPA staff is also required to review and process all payments within the claim to MBR. MBR payments are electronically uploaded to the claim in Origami. The State reviews and approves all payments for check printing. The State is responsible for stop pay/voiding checks, entering overpayment recoveries, and processing Second Injury Fund reimbursements. The State can provide the TPA with reports for statistical data.

10. Question: Will the State provide with access to it workers' compensation claims data – through Origami - to the extent the account manager can use this same data to guide the claim team's performance and identify process improvement opportunities?

Answer: The contracted TPA staff will have access to the State's claims data through Origami. The Account Manager will be able to use data reports and dashboards to guide staff performance and identify process improvement opportunities.

11. Question: Please provide the current salary for each of the incumbent's claim team members. If this is not possible please provide an average for each position.

Answer: Contract is a set annual amount. The State is unaware of and unable to provide current TPA staff salaries.

12. Question: With respect to the \$2M annual fee cap, is this applicable only to Year 1? Or is it applicable only to Years 1-3? Or is it applicable to Years 1-7?

Answer: The annual fee cap of \$2Mil is a per year cap and cannot be exceeded in all years (1-7).

13. Question: Please provide a report that identifies all open claims, by claim type, to include the Date of Loss, across all years.

Answer: Please see the open claims report at the end of this amendment.

14. Question: In Section 1.02 Budget; What is the meaning of "Payment for the contract is subject to funds already appropriated and identified", as compared to previous RFP's wording that the contract was "Contingent" upon appropriation of the legislature?

Answer: Budget approved by Governor.

15. Question: In Section 3.07 Trips to Juneau; Are the trips to Juneau limited to the Claims Manager and Adjuster staff?

Answer: Trips to Juneau for bi-annual meeting(s) should include entire staff, not only Claims Manager and Adjuster staff.

- **16. Question:** In Section 4.06 Personnel Roster; Bullet #4 (page 18) —"Itemize the total cost and the number of estimated hours for each individual named above"
 - a. What is the purpose and need for the itemized list?
 - b. Is SOA taking over care, custody and control at itemized staffing and expense levels?

Answers:

- (a) See amendment 3; section 4.06 amended.
- (b) SOA is not taking over care, custody and control at itemized staffing and expense levels.

17. Questions: Section 4.08 Cost Proposal; During the Pre-Bid Conference on 7/9/2018, it was suggested that Attachment B, the Cost Proposal Form, would "override" or be the guiding reference related to this particular topic. However, there was a suggestion within the RFP that not conforming to Sections 4.06 or 4.08 would leave the bid considered non-responsive. Please clarify, in writing. And, if these sections remain. Specific to section 4.08, the question is why does the SOA need this detail costing breakdown?

- a. Does the SOA have a Published Antitrust Policy? Please include.
- b. As reviewed within other Antitrust Policy compliance language, how will the SOA ensure such requested data complies with common Antitrust language, i.e. 'discourages and prohibits the disclosure of competitive information that does not further the purposes of (the SOA) and that might, under certain circumstances and along with other conduct, be alleged to violate federal or state antitrust laws'

- **18. Questions:** Attachment B Cost Proposal Form; Is the \$2,000,000 annual cap related to each and every year, from 1-7, individually or if any of the 7 years were over \$2,000,000 would the bid be considered non-responsive? I.e. if years 1-6 were under \$2,000,000, but year 7 was over, will it be considered non-responsive?
 - c. On this form, cell (A3) for entry of offeror's name is locked, please provide password to unlock protected cell.

- **19. Question:** Please provide your current TPA staffing level to include paralegal, and support staff.

Answer: Current TPA staffing includes: one Claims Manager, two Senior Adjuster's, two MO Adjuster's, three TL Adjuster's, six Support staff, and one Paralegal.

20. Question: What is the average monthly open claim volume for the last 12 months?

21. Question: Is there expectation for hierarchy (locations) or special coding for claims?

Answer: Every claim must be entered according to the existing coding and location hierarchy utilized within our claims system.

- **22. Questions:** Medicare Reporting vendor was stated as the claim system, Origami, for eligibility queries and quarterly reporting.
 - a. Please define the Adjuster/TPA responsibility when claimant has been identified as a Medicare Beneficiary?
 - b. What subsequent expectation would be required after initial reporting to Medicare has occurred?
 - c. Describe TPA action in event of letter received from CMS relating to conditional payments?

Answers:

- a. Origami automatically generates a Task for the adjuster to complete the CMS report within the specific claim file. It is the responsibility of the adjuster to timely and accurately complete this reporting.
- b. Adjusters are expected to answer and complete any additional automatically generated CMS reporting Tasks as well as respond timely to written inquiries received from CMS. All communication is to be documented to the claim file.
- c. If CMS conditional payment letter is received by TPA then a Letter of Authority will need to be obtained from the State. TPA is then expected to work with the State Claim Administrator to respond appropriately.
- **23. Question:** If the TPA requires additional Origami users above the (20) authorized amount, will there be any associated costs to the TPA?

Answer: If additional Origami user licenses are required above the current 20 allowed then the cost for additional licenses will be incurred by the State.

24. Question: Assuming the TPA has the flexibility to manage any back-scanning project, what amount of back-scanning is expected annually?

Answer: There are approximately 500 banker boxes of paper (legacy) files remaining to be scanned. Once the remaining boxes have been scanned, no additional paper files will exist, and no annual back-scanning is expected.

- **25. Questions:** What is the expectation of TPA for back-scanning of historical files still in paper form?
 - a. How many paper files (boxes) currently exist?
 - b. Will TPA be responsible for storage of paper files and any associated fees for storage?
 - c. Is cost of labor for back-scanning to be included in contracting/RFP pricing?

Answers:

- a. There are approximately 500 banker boxes of scanning remaining (see #24 above).
- b. The TPA is responsible for storage of paper files and any associated fees for storage.
- c. Cost of labor for back-scanning claim file onto a CD for direct claim upload is currently being paid as an ALAE within each claim.
