CONTRACT INTENT: This Invitation to Bid (ITB) is intended to result in the Abatement of Lead located within the Indoor Firing Range at the Alaska Army National Guard Readiness Center, at Kotzebue, for the Department of Military and Veterans Affairs.

PREBID CONFERENCE: There will be a **NON-MANDATORY** pre-bid conference on **August 7, 2018** beginning at **10:00AM Alaska Time** in the Conference Room, located at the Facilities Maintenance Office, Building 57024 Roosevelt Road, Fort Richardson. Parking spaces are available. The conference may take several hours depending on the length of discussion of individual provisions. Participants should read the ITB and come to the meeting prepared to discuss any concerns. This will be a teleconference and potential bidders are invited to attend in person, email mvafmocontracts@alaska.gov for information on how to dial into the conference.

NOTICE OF INTENT TO AWARD: After the responses to this ITB have been opened and evaluated, a tabulation of the bids will be prepared. This tabulation, called a Notice of Intent to Award, serves two purposes. It lists the name of each company or person that offered a bid and the price they bid. It also provides notice of the state's intent to award a contract(s) to the bidder(s) indicated. A copy of the Notice of Intent will be mailed to each company or person who responded to the ITB. Bidders identified as the apparent low responsive bidders are instructed not to proceed until a Purchase Order, Contract Award, Lease, or some other form of written notice is given by the contracting officer. A company or person who proceeds prior to receiving a Purchase Order, Contract Award, Lease, or some other form of written notice from the contracting officer does so without a contract and at their own risk.

PAYMENT FOR STATE PURCHASES: Payment for agreements under \$500,000 for the undisputed purchase of goods or services provided to a state agency, will be made within 30 days of the receipt of a proper billing or the delivery of the goods or services to the location(s) specified in the agreement, whichever is later. A late payment is subject to 1.5% interest per month on the unpaid balance. Interest will not be paid if there is a dispute or if there is an agreement that establishes a lower interest rate or precludes the charging of interest.

FEDERAL EXCISE TAX: The State of Alaska is exempt from Federal Excise Tax except for the following:

The State of Alaska is exempt from State Motor Fuel Taxes. The appropriate exemption forms will accompany a contract(s) resulting from this ITB. The state is not exempt from the Federal Superfund Tax.

CONTRACT ADMINISTRATION: The administration of this contract is the responsibility of Colby Thurston, contracting officer (or project manager), Department of Military and Veterans Affairs.

SHIPPING DAMAGE: The state will not accept or pay for damaged goods. The contractor must file all claims against the carrier(s) for damages incurred to items in transit from the point of origin to the ultimate destination. The state will provide the contractor with written notice when damaged goods are received. The state will deduct the cost of the damaged goods from the invoice prior to payment. The contractor must file all claims against the carrier(s) for reimbursement of the loss.

INDEMNIFICATION: The contractor shall indemnify, hold harmless, and defend the contracting agency from and against any claim of, or liability for error, omission or negligent act of the contractor under this agreement. The contractor shall not be required to indemnify the contracting agency for a claim of, or liability for, the independent negligence of the contracting agency. If there is a claim of, or liability for, the joint negligent error or omission of the contractor and the independent negligence of the Contracting agency, the indemnification and hold harmless obligation shall be apportioned on a comparative fault basis. "Contractor" and "Contracting agency", as used within this and the following article, include the employees, agents and other contractors who are directly responsible, respectively, to each. The term

“independent negligence” is negligence other than in the Contracting agency’s selection, administration, monitoring, or controlling of the contractor and in approving or accepting the contractor’s work.

INSURANCE: Without limiting contractor's indemnification, it is agreed that contractor shall purchase at its own expense and maintain in force at all times during the performance of services under this agreement the following policies of insurance. Where specific limits are shown, it is understood that they shall be the minimum acceptable limits. If the contractor's policy contains higher limits, the state shall be entitled to coverage to the extent of such higher limits. Certificates of Insurance must be furnished to the contracting officer prior to beginning work and must provide for a notice of cancellation, non-renewal, or material change of conditions in accordance with policy provisions. Failure to furnish satisfactory evidence of insurance or lapse of the policy is a material breach of this contract and shall be grounds for termination of the contractor's services. All insurance policies shall comply with, and be issued by insurers licensed to transact the business of insurance under AS 21.

Proof of insurance is required for the following:

Workers' Compensation Insurance: The contractor shall provide and maintain, for all employees engaged in work under this contract, coverage as required by AS 23.30.045, and; where applicable, any other statutory obligations including but not limited to Federal U.S.L. & H. and Jones Act requirements. The policy must waive subrogation against the state.

Commercial General Liability Insurance: covering all business premises and operations used by the contractor in the performance of services under this agreement with minimum coverage limits of \$300,000 combined single limit per occurrence.

Commercial Automobile Liability Insurance: covering all vehicles used by the contractor in the performance of services under this agreement with minimum coverage limits of \$300,000 combined single limit per occurrence.

Hazardous Pollution Coverage Insurance: covering all activities by the contractor in the performance of services under this agreement with minimum coverage limits of \$1,000,000 combined single limit per occurrence.

Failure to supply satisfactory proof of insurance within the time required will cause the state to declare the bidder non-responsible and to reject the bid.

FIRM, UNQUALIFIED AND UNCONDITIONAL OFFER: Bidders must provide enough information with their bid to constitute a definite, firm, unqualified and unconditional offer. To be responsive a bid must constitute a definite, firm, unqualified and unconditional offer to meet all of the material terms of the ITB. Material terms are those that could affect the price, quantity, quality, or delivery. Also included as material terms are those which are clearly identified in the ITB and which, for reasons of policy, must be complied with at risk of bid rejection for non-responsiveness.

BID BOND: Bids must be accompanied by a Bid Bond in the form of a Certified or Cashier's check in the amount of **5% of Bid Total** made payable to the State of Alaska. The Bid Bond of each successful bidder will be retained until that bidder has furnished a satisfactory Performance Bond or Individual Surety. If the successful bidder fails to deliver the required Performance Bond or Individual Surety within the time required, the Bid Bond will be forfeited to the State of Alaska. SPECIFICATIONS / SCOPE OF WORK

Alaska Army National Guard IFR Lead Abatement, Kotzebue Project Number: 09-3001-02C0117032

Contractor to perform all work as required to convert current Alaska Army National Guard Indoor Firing Range (IFR) to storage space, and all related improvements, located in Kotzebue, Alaska.

Site Specific Summary of Work Includes:

- Remove and properly dispose of existing backdrop materials including controls, bullet trap, and all Material Contain Lead (MCL) within. Electrical components to be removed back to panel.
- Remove and properly dispose of existing exhaust fan system and associated ductwork to include roof stack, controls, and electrical components. Electrical components to be removed back to panel.
- Provide and install adequate return air for HVAC system ensuring proper air exchanges for storage rooms.
- Repair roof penetrations from exhaust system removal to include pan deck material, concrete, and roofing material to match existing.
- Configure containment protection to allow access to closest exit to a man-door.
- Verify and modify existing fire suppression system sprinkler heads to meet or exceed current UFGS standards for storage rooms.
- Remove and replace current lighting fixtures and associated switches with new LED units in accordance with current UFC standards for storage rooms.
- Remove and properly dispose of temporary wall installed within existing IFR to include framing members, gypsum wall board, fasteners, and stand offs.
- Remove and properly dispose of all cove base, plywood, acoustical ceiling tiles, fasteners, adhesive, brackets, hangers, and strapping present. Reinstall all electrical and mechanical controls to block wall at original locations and verify function.
- Remove, clean, and reinstall all HVAC equipment within existing IFR in accordance with National Guard standards.
- Fill and level concrete floor from any previous action as well as fill and level disturbed areas of floor and walls and any existing penetrations.
- Remove any dust from roof structural members, pan decking, trusses, and joists anywhere in the Exposed Ceiling Area.
- Lead abatement cleaning for MCL of all large air handling mechanical units including the units interior and exterior. Also includes any smaller units hanging from the ceiling.
- Lead abatement cleaning for MCL interior and exterior of all mechanical supply ductwork/chase and all return ductwork/chase if present.

- Remove flush to adjacent surface, and properly dispose of all metal plates, structural steel, metal bolts, threaded rods, etc. any metal protruding from the ceiling, walls, or floor. **Ensure all items are cut flush to adjacent surface.**
- Apply two coats of high build primer to all surfaces, ensuring sufficient coverage to the roof structural members, pan decking, trusses, and joists in the Exposed Ceiling Area. Coverage must pass Project Manager's approval.
- Apply two coats lead encapsulant to all surfaces including roof structural members, trusses, joists, mechanical piping, electrical conduit, and plumbing piping.
- Do not encapsulate any small in-line mechanical fixtures, sensors, valves, etc.
- Do not encapsulate any electrical fixtures, etc.
- Do not encapsulate any plumbing fixtures, etc.
- All metal man-doors and trim located at IFR will be lead abated, cleaned, primed, and encapsulated.
- Apply flooring encapsulant to all cleaned floor surfaces within IFR and allow to fully cure.
- Install VCT and Vinyl Cove Base to match existing.
