ORDER ADOPTING CHANGES TO
REGULATIONS OF THE DEPARTMENT OF COMMERCE,
COMMUNITY, AND ECONOMIC DEVELOPMENT

The attached two pages of regulations, dealing with occupational licensing fees for Physicians, Osteopaths, Podiatrists, Physician Assistants and Mobile Intensive Care Paramedics regulated by the State Medical Board, are adopted and certified to be a correct copy of the regulation changes that the Department of Commerce, Community and Economic Development adopts under the authority of AS 08.01.062, AS 08.01.065, AS 08.64.107, AS 08.64.270, AS 08.64.272, AS 08.64.276, AS 08.64.315, and after compliance with the Administrative Procedure Act (AS 44.62), specifically including notice under AS 44.62.190 and 44.62.200 and opportunity for public comment under AS 44.62.210.



Chapter 02. General Occupational Licensing Functions.

(Words in **boldface and underlined** indicate language being added; words [CAPITALIZED AND BRACKETED] indicate language being deleted.)

12 AAC 02.250 is amended to read:

12 AAC 02.250. State Medical Board. (a) The following fees are established for physicians, podiatrists, and osteopaths:

- (1) nonrefundable application fee for initial license, **\$400** [\$200];
- (2) temporary permit fee, **\$200** [\$75];
- (3) initial or extended locum tenens permit fee, **\$150** [\$100];
- (4) license fee for all or part of the initial biennial license period, **\$425** [\$300];
- (5) active biennial license renewal fee, **\$425** [\$300];
- (6) inactive biennial license renewal fee, **\$275** [\$125];
- (7) retired status license one-time fee, **\$150** [\$50];
- (8) courtesy license fee, **\$150** [\$100];

- (5) fee for establishing or changing a collaborative relationship, **\$125** [\$100];
- (6) license fee for all or part of the initial biennial license period, **\$250** [\$200];

(7) biennial license renewal fee, **\$250** [\$200];

(8) graduate physician assistant nonrefundable application and license fee, **\$100** [\$50];

(9) inactive biennial license fee, **\$175** [\$100].

(c) The following fees are established for mobile intensive care paramedics:

(1) nonrefundable application fee for initial license, **\$100** [\$50];

(2) temporary permit fee, **\$75** [\$50];

(3) provisional license fee, **\$75** [\$50];

(4) license fee for all or part of the initial biennial license period, **\$75** [\$50];

(5) biennial license renewal fee, **\$75** [\$50]. The Department of Law has reviewed the attached regulations of the Department of Commerce, Community, and Economic Development against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department after the close of the public comment period. The regulations concern fees for physicians, podiatrists, osteopaths, physician assistants and mobile intensive care paramedics.

The June 5, 2018 public notice and the July 11, 2018 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

BRIEF DESCRIPTION: The Department of Commerce, Community, and Economic Development proposes to change occupational license fees charged to physicians, osteopaths, podiatrists, physician assistants, and mobile intensive care paramedics.

The Department of Commerce, Community, and Economic Development (Department) proposes to adopt regulation changes in Title 12, Chapter 02 of the Alaska Administrative Code, dealing with occupational licensing fees, including the following:

12 AAC 02.250. State Medical Board, is proposed to be changed to alter the application, license and renewal fees for physicians, osteopaths, podiatrists, physician assistants and mobile intensive care paramedics.

Under AS 08.01.065, the Department must establish fee levels so that the total amount of fees collected for an occupation approximately equals the actual regulatory costs for the occupation. The Department has reviewed the income and expenses for the occupational licensing program for the State Medical Board and proposes fee changes that reflect, to the extent possible, the actual costs of the activities related to the program.
