DEMOLITION PLAN NOTES:

1. ALL ITEMS SCHEDULED FOR DEMOLITION WILL BE REMOVED FROM THE PROJECT SITE AND SHALL BE PROPERLY DISPOSED OF BY THE CONTRACTOR UNLESS NOTED OTHERWISE.
2. OWNER RESERVES THE RIGHT TO SALVAGE ITEMS FROM THE SITE PRIOR TO CONTRACTOR MOBILIZATION AND DURING DEMOLITION. CONTRACTOR TO NOTIFY OWNER 72-HOURS PRIOR TO SITE MOBILIZATION.
3. VERIFY EXISTING SITE CONDITIONS AND ALL DEMOLITION ITEMS WITH THE OWNER.
4. THE CONTRACTOR IS RESPONSIBLE FOR THE DEMOLITION AND REMOVAL OF ALL EXISTING ITEMS NECESSARY FOR COMPLETION OF THE WORK.
5. DO NOT DISTURB EXISTING CANOPY SUPPORTS AND ELECTRICAL CONDUITS.
6. MAINTAIN ACCESS TO ALL COTTAGES, SCHOOL AND CAFETERIA AT ALL TIMES.
7. MAINTAIN ELECTRICAL POWER TO ALL COTTAGES, SCHOOL AND CAFETERIA AT ALL TIMES.



CONCRETE RESURFACING PREPARATION NOTES:

1. CONCRETE SURFACE MUST BE CLEAN AND FREE OF LOOSE PARTICLES EFFLORESCENCE, PAINTS, TARS, GREASE, ASPHALTIC MATERIALS, BOND BREAKERS, CURING COMPOUNDS, WAX, AND ANY FOREIGN SUBSTANCE OR ANY CONDITIONS THAT MAY AFFECT PRODUCT PERFORMANCE OR PROPER BONDING.
2. ENSURE THAT ANY CONCRETE THAT HAS BEEN DAMAGED OR WEAKENED (SUCH AS BY DE-ICING SALTS) IS MECHANICALLY REMOVED. REMOVE CONCRETE UNTIL A SOUND SUBSTRATE HAS BEEN ACHIEVED.
3. MECHANICALLY PROFILE AND PREPARE CONCRETE SURFACES BY SHOTBLASTING TO A MODERATE PROFILE .
4. SWEEP AND VACUUM AREA TO COLLECT DEBRIS .
