**This a MANDATORY return amendment.** Information is being provided to address questions from potential offerors.

**1. Question:** It says that this is not Davis Bacon wages but is it any other type of wages or is it regular wages that we pay our employees?

**Response:** Service contracts do not require Davis Bacon wages. Contractor would pay their "Normal" wages.

**2. Question:** On the bid schedule for lot 1 it asks for the total of extended price for a+b+c. Is this a typo because lot 2 is item a and lot 1 is d, e and f?

**Response:** Corrected bid schedule is attached.

**3. Question:** For lot 1 there is no item no. for hauling or loader use for moving snow from 1 spot to another. Is this supposed to be inclusive?

**Response:** When managed properly for a normal snow season - Snow collection area will have sufficient capacity. In the event the yearly snow accumulation is significantly above average, additional snow collection areas will be identified. An updated map has been attached.

**4. Question:** When the total of extended prices for both lots are calculated is it the total of per event or the total for 1 year? (price multiplied by 12 months)

**Response:** Total for Lot 1 is based on the total of event costs of items a, b, and c. The total for Lot 2 is the monthly rate for ground maintenance service. Not multiplied by 12 months.
