Dear municipalities and interested parties:

In 2018, the Alaska State Legislature enacted HB 267, allowing certain data regarding big game hunting records to be released to municipalities that have adopted ordinances to tax Registered Guide-Outfitters, Master Guide-Outfitters, and Transporters, whose licenses are regulated by this agency and the Big Game Commercial Services Board. This data is confidential per 08.54.760; distribution or release of this information by the requesting agency or its staff is punishable as a crime under AS 11.56.850-860.

You are receiving this notification because the Division of Corporations, Business and Professional Licensing proposes to establish a fee to cover the cost of processing these requests. Per state law, fees must be set so that the total amount of fees collected by the department equals the total operational costs of the database minus all federal funds acquired for the operational costs of the database.

## The proposed fee amount is \$500 per quarterly hunt record request.

This fee proposal is entering a public comment period. The division encourages all licensees and interested parties to comment on this proposal through the division's Regulations Specialist, whose contact information is enclosed on the public notice. After the comment period closes and the division reviews all comments received, the division may adopt the regulation as drafted, may amend a proposed fee, or may withdraw the regulations in part or in its whole.

All comments received will be reviewed and taken into consideration prior to adopting the final regulations.

Follow the instructions enclosed to make written comments during the public comment period. ## **Chapter 02. General Occupational Licensing Functions.**

12 AAC 02.230 is amended by adding a new subsection to read:

(e) The following fee is established for each municipality request for hunt record and transporter activity report information under AS 08.54.760(b)(2), \$500.
