#### Transcript of Public Meeting

September 12, 2018

CHAIR FATE PUTMAN: This is Fate Putman, Chair of the Commercial Fisheries Entry Commission. It is 3:30 on Thursday, September 12, and we are holding a meeting today seeking public comment to changes to our regulations. This is a public meeting of the CFEC for consideration of adopting those proposed amendments to Title 20, Chapter Five of the Alaska Administrative Code pertaining to reduced fees, and specifically, we will be amending 20 AAC 05.245(c) – (e), 20 AAC 05.250(b) and 20 AAC 05.1910(h). As the Chair of this, I would like to present this to the Commission and to Commissioner Kelley. And the two of us together under the new statute constitutes a quorum of the Commission.
