AGENDA CHANGE REQUEST FORM

ALASKA BOARD OF GAME

The Board of Game (Board) will accept requests to change its schedule under certain guidelines set forth in 5 AAC 92.005. The board will accept these agenda change requests (ACRs) only:

- 1) To correct an error in regulation;
- 2) To correct an effect of a regulation that was unforeseen when the regulation was adopted;
- 3) If the request identifies a biological concern for the population or a threat to meeting objectives for the population;
- 4) If the request identifies an unforeseen, unexpected event or effect that would otherwise restrict or reduce a reasonable opportunity for customary and traditional wildlife uses, as defined in <u>Alaska Statute</u> 16.05.258(f); or
- 5) If the request identifies an unforeseen, unexpected resource situation where a biologically allowable resource harvest would be precluded by delayed regulatory action and such delay would be significantly burdensome because the resource would be unavailable in the future.

The board will not accept an ACR that is predominantly allocative in nature in the absence of new compelling information, as determined by the board [5 AAC 92.005 (a)(3)].

Please answer all questions to the best of your ability. The information submitted on the ACR form will be used to develop the proposal if accepted by the Board of Game.

2) WHAT IS THE PROBLEM YOU WOULD LIKE THE BOARD TO ADDRESS? STATE IN DETAIL THE NATURE OF THE CURRENT PROBLEM. Address only one issue. State the problem clearly and concisely. The board will reject multiple or confusing issues.

In March 2018 the fall season length for brown bears in Unit 9 was shortened to Oct 7-21 and the spring season length was shortened to May 10-25 because of concern for overharvest. However, this concern does not extend to Unit 9B where harvest and human population is lower, and bears tend to den earlier in the fall. AC's and local guides are requesting a return to fall season dates of Sept. 20 to Oct. 21 and spring season dates of May 10-31 for Unit 9B. The department does not object to the change.

- **3) WHAT SOLUTION DO YOU PREFER?** Or, if the board adopted your solution, what would the new or amended regulation say?
 - Unit 9(B)...Residents and nonresidents
 - 1 bear every 4 regulatory years by registration permit only. Sept. 20—Oct. 21 (Odd years only) May 10—31 (Even years only)
- **4) STATE IN DETAIL HOW THIS ACR MEETS THE CRITERIA STATED ABOVE.** If one or more of the five criteria set forth above is not applicable, state that it is not.
 - a) To correct an error in regulation:
 - The department's intent was for shorted seasons for Units 9C, 9D, and 9E, the southern portion of the Alaska Peninsula. This was expanded to include all of Unit 9 during deliberations and went unnoticed.

- b) To correct an effect of a regulation that was unforeseen when a regulation was adopted:

 Bears in Unit 9B move into the high country for denning early in October, making them much more difficult to access for hunters, unnecessarily reducing opportunity.
- Does the request identify a biological concern for the population or a threat to meeting objectives for the population?
 None
- d) Does the request identify an unforeseen, unexpected event or effect that would otherwise restrict or reduce a reasonable opportunity for customary and traditional wildlife uses, as defined in AS 16.05.258(f)? No, there is an extended season (Sept. 1—May 31) for resident subsistence hunters and a year-round, near-village registration hunt for resident participation.
- e) Does the request identify an unforeseen, unexpected resource situation where a biologically allowable resource harvest would be precluded by delayed regulatory action and such delay would be significantly burdensome because the resource would be unavailable in the future?

 Yes- Nonresident hunters who have already booked guided hunts in fall, 2019 (this biennial season occurs during odd years only) must be rescheduled or cancelled. If this change were made at the next regular meeting in 2021, guides and hunters in Unit 9B would have limited fall opportunity until fall, 2021. There would be little change in availability of bears three years from now.
- 5) WHAT WILL HAPPEN IF THIS PROBLEM IS NOT SOLVED PRIOR TO THE REGULAR CYCLE? Loss of bear hunting opportunity for guides and hunters in Unit 9B for several years.
- 6) STATE WHY YOUR ACR IS NOT PREDOMINANTLY ALLOCATIVE.

Season length for residents and nonresidents is the same for biennial hunts, with guided nonresidents typically taking 75—100% of the harvest. In addition, residents have subsistence hunt RB502 (Sept. 1—May 31) and near-village RB525 (year-round). Total harvest with biennial hunts open are typically 20—60 bears in Unit 9B, and less than 5 when resident-only seasons are open.

- 7) IF THIS REQUEST IS ALLOCATIVE, STATE THE NEW INFORMATION THAT COMPELS THE BOARD TO CONSIDER AN ALLOCATIVE PROPOSAL OUTSIDE OF THE REGULAR CYCLE. We do not consider this an allocative issue.

The Lake Iliamna Fish and Game Advisory Committee Advisory committee is a local group with members from the communities of Iliamna, Nondalton, Pedro Bay, Kokhanok, Igiugig, Newhalen, Port Alsworth, and Pope Vannoy that meets to discuss fishing and wildlife issues and to provide recommendations to Alaska Board of Fisheries and Alaska Board of Game.
