This verification can be completed formally or informally as desired. An updated list may be requested through the ECOS-IPaC system by completing the same process used to receive the enclosed list.

The purpose of the Act is to provide a means whereby threatened and endangered species and the ecosystems upon which they depend may be conserved. Under sections 7(a)(1) and 7(a)(2) of the Act and its implementing regulations (50 CFR 402 et seq.), Federal agencies are required to utilize their authorities to carry out programs for the conservation of threatened and endangered

species and to determine whether projects may affect threatened and endangered species and/or designated critical habitat.

A Biological Assessment is required for construction projects (or other undertakings having similar physical impacts) that are major Federal actions significantly affecting the quality of the human environment as defined in the National Environmental Policy Act (42 U.S.C. 4332(2) (c)). For projects other than major construction activities, the Service suggests that a biological evaluation similar to a Biological Assessment be prepared to determine whether the project may affect listed or proposed species and/or designated or proposed critical habitat. Recommended contents of a Biological Assessment are described at 50 CFR 402.12.

If a Federal agency determines, based on the Biological Assessment or biological evaluation, that listed species and/or designated critical habitat may be affected by the proposed project, the agency is required to consult with the Service pursuant to 50 CFR 402. In addition, the Service recommends that candidate species, proposed species and proposed critical habitat be addressed within the consultation. #### MEMORANDUM FOR RECORD

SUBJECT: Endangered Species Act (ESA) Section 7 Consultation for Implementation of a Wildlife/Bird Aircraft Strike Hazard (BASH) Plan at Bryant Army Airfield, Joint Base Elmendorf-Richardson, Alaska—No Species Present

- 1. The Alaska Army National Guard (AKARNG) proposes to implement a BASH Plan to protect aircraft from bird-wildlife strikes at Bryant Army Airfield (BAAF) on Joint Base Elmendorf-Richardson (JBER). The BASH Plan entails modifying aircraft operations during high-risk periods; excluding birds and wildlife from the airfield environment by fencing and active hazing; and substantially modifying 212 acres of habitat in the airfield and the approach-departure clear zone to reduce attractiveness to birds and wildlife and to ensure that birds and wildlife in the runway environment can be seen by operations personnel. The Plan would be implemented following approval of an Environmental Assessment evaluating the potential environmental effects of the Proposed Action.
- The AKARNG has reviewed the available Threatened, Endangered, and Candidate (TEC) species information for the possibility of impacts to TEC species in Alaska associated with the Proposed Action.
- 3. The U.S. Fish and Wildlife Service (USFWS) maintains a current list of TEC species for Alaska. Coordination was conducted with the USFWS through their Information for Planning and Conservation (IPaC) website. A query to the IPaC website on 05 October 2018 identified no TEC species at or near the project site. The USFWS TEC species letter for the subject action is enclosed.
- 4. No ESA listed species, habitat for ESA listed species, or designated critical habitat occur, or are known to occur, within the Proposed Action area. Therefore, with no species present, there will be no effect on ESA listed species or critical habitat.
