Questions submitted by potential offerors and answers from the State:

Question 175: Regarding the State's response to Question 154 in Amendment 7:

Since we are no longer required to submit baseline disruption data for the Dental RFP, please confirm that bidders do not need to complete the tables in 3.10.1 and 3.11.1. Will these sections be removed from ProposalTech? If not, will a comment field be added so that bidders can indicate compliance with Amendment 7? If the tables in 3.10.1 and 3.11.1 are still to be completed, how is the State defining Baseline Data vs. Bidder Results?

Answer: The offeror is not required to submit results for the baseline data in ProposalTech sections 3.10.1 and 3.11.1. The baseline fields have been pre-filled with zeros. Please complete ProposalTech sections 3.10.2 and 3.11.2.
