2 AAC 70.110(a)

In accordance with the authority of the regulations attorney under AS 44.62.125(b), please forward to the publisher the corrections to the Alaska Administrative Code (AAC) described below. I have forwarded these corrections under a specific delegation dated December 1, 2015 from the regulations attorney. These revisions correct manifest errors.

The regulation to be revised is 2 AAC 70.110(a). The revisions to that subsection are as follows:

--In the introductory language of 2 AAC 70.110(a)(1), delete the semicolon at the end

--In 2 AAC 70.110(a)(11), change "row boat" to "rowboat"

--In 2 AAC 70.110(a)(14), change "sterndrive" to "sterndrive"

In addition, after 2 AAC 70.110, please insert an editor's note to read as follows:

**Editor's note:** As of Register 228 (January 2019), the regulations attorney made technical revisions under AS 44.62.125(b)(6), to 2 AAC 70.110(a).
