NOTICE TO BIDDERS

The bid documents require acknowledgment individually of all addenda to the drawings and/or specifications. This is a mandatory requirement and any quote received without acknowledgment of receipt of addenda may be classified as not being a responsive bid. If, by virtue of this addendum it is desired to modify a quote already submitted, such modification may be made by telegram or telefacsimile provided such a telegram or telefacsimile makes reference to this addendum and is received prior to the opening hour and date specified above.

Questions / Answers:

1. **Question:** What do you plan on storing in this building?
 - a. **Response:** This is overflow storage and will contain miscellaneous firefighting supplies. Most items will be in fiberboard boxes, palletized and stacked or on pallet shelving.
2. **Question:** Can you email me site pictures and/or confirm the site layout showing elevations changes, property lines, etc.?
 - a. **Response:** We don't have any pictures of the site and the pad is currently covered with snow. This structure will be on State of Alaska property. The site is a level compacted gravel pad.
3. **Question:** Do you having any drawings or height requirements for the fabric building solution?
 - a. **Response:** The structure must be a straight wall design as we will be stacking pallets. There is no maximum height so the overhead door and any above door vents, framing, etc. will be the determining factor.
4. **Question:** Do you have any drawings or additional detail regarding the foundation?
 - a. **Response:** We have no drawings of the site pad. The pad is compacted gravel.
5. **Question:** Are there any OSHA requirements we should take into account?
 - a. **Response:** The Department of Natural Resources, Division of Forestry is unaware of any OSHA requirements however it is the responsibility of the contractor to determine and comply with any OSHA or other federal, state, or local requirements applicable to compliance with the services required by this IFQ.

There are no further changes to this IFQ at this time.
