# Request for Proposal P19-004 is hereby amended as follows:

RFP P19-004 Attachment 1- Financial Workbook has been reviewed and updated. RFP P19-004 Attachment 1- As Revised by Amendment 2 is issued to replace the previous version. The revised attachment contains the following corrections and updates:

- 1. The Block Plan 175 was listed with an incorrect amount of dining dollars in P19-004 Attachment 1- Financial Workbook. This has been remedied and listed for the correct amount, of 325 dining dollars.
- 2. The non-resident dining plan offerings erroneously included Block 50 + 300 Dining Dollars and Block 25 + \$250 Dining Dollars offerings. These have been deleted from the attachment and replaced with UAA's current offerings. The current offerings are a block of 25 or 10 meals and Dining Dollar add-ons containing \$300 DD + 9 meals, \$200 DD + 6 meals, and \$100 DD + 3 meals.
- 3. The Assumed Annual Operating days were incorrectly listed as 109 for the fall semester and 106.33 for the spring semester. The correct number of operating days for both semesters is 116.

The following details are provided for further clarification of the information contained in - RFP P19-004 Attachment 1- As Revised by Amendment 2.

- The estimated price per semester for each meal plan is entered at the same price for years 1 through 5.
   This pricing is currently in effect, but it is included primarily for evaluation purposes. It is the University's desire to price student meal plans as affordably as possible, with the aim of encouraging participation and keeping costs reasonable. UAA may increase plan pricing when driven by market factors such as increased food costs and operating costs.
- 2. The existing data and estimates in Attachment 1- As Revised by Amendment 2 are intended to provide an even basis for comparison, and should not be modified by the Offeror.
