The Department of Law has reviewed the attached regulations of the Marijuana Control Board against the statutory standards of the Administrative Procedure Act. Erika McConnell summarizes Tab 26, regulations project "License Fees", and discusses the difficulty in predicting the license fee revenues from Marijuana, and that AMCO will no longer get fiscal support from general fund starting in FY 20.

Vote to adopt; OR

Mark Springer states that there is minimal public comment in favor of the license fee increases and asks why concentrate only license fees are so low.

Brandon Emmett states that the original intent of the concentrate only licenses was to be similar to a "limited grow". He discloses that he has a public Facebook and that he has been flooded with comments and questions regarding this matter. He finds that small growers are the most impacted by this change and they find it inappropriate that they are getting a 100% increase. He finds that the industry that is generating so much revenue should not be considered to "owe the government money". He is on the fence about if the large cultivation fees should be increased or if the smaller grow fees should be decreased. He would like to hear from the rest of the board regarding their thoughts of this matter.

Mark Springer asks that, given the number of licenses, what the revenue impact on the office would be.

Erika McConnell references the December tab for this matter, where she provided a chart that indicated revenue generation increase created by multiple proposals.

Emmett mentioned that the ballpark was 4.5-5 million approximately.

Erika McConnell states that the increase in revenue would be 600 thousand, with a total of slightly over 2 million dollars.

Mark springer asks if the fees are split with LG, McConnell confirms that the application fee is split.

Brandon Emmett wishes to hear from the larger growers regarding this matter. He wants to know if the big grows can take more of the proposed burden. He states that ultimately people will be unhappy either way.

Brandon Emmett motions to send back out for public comment for an additional 30 days. Nick Miller seconds the motion and asks that the director republish the table as well.

Loren Jones states that he has a problem for this to go back out for public comment, he finds that logistically this would not provide enough time for the fees to be in place before the renewal process, and he finds that implementing this before the renewal period is important.

Harriet Milks addresses Loren Jones concerns, she states that the idea that the matter needs to go back out for public comment for substantiative changes is to protect the public/licensees. Reducing the limited cultivation fees would not require republication but increasing the standard cultivation fees would not be considered necessary to go back out for public comment.

Mark Springer and Erika McConnell discuss if budget projections include these revenue increases, and when the fees would go into effect.

Brandon Emmett asks if small grows are reduced to a 1400\$ fee the project would not need to go back out to public comment.

Harriet Milks confirms that this is her opinion.

Brandon Emmett withdraws his motion, and motions to change the fee for small cultivators to 1400 and then adopt the regulations project "License Fees".

Nick Miller seconds the motion.
