4.8.2 Offeror Capabilities

Offeror shall indicate which category(s) the Offeror intends to propose on; how many manufacturers they are certified to resell in their chosen category(s); whether the Offeror intends to provide the Products nationally or Alaska statewide, and how they meet the requirements of Sections 4.4,4.5, and 4.6.
