The Department of Law has reviewed the attached regulations of the Department of Commerce against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Commerce after the close of the public comment period. The regulations concern reducing the biennial occupational licensing fees for athletic trainers. *The department requests that these be filed in order to be effective by July 26, 2019, for the upcoming August renewal.*

The May 8, 2019, public notice and the June 20, 2019, adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

No corrections were required.

BRIEF DESCRIPTION: The Department of Commerce, Community, and Economic Development proposes to change occupational license fees charged to athletic trainers.

The Department of Commerce, Community, and Economic Development (Department) proposes to adopt regulation changes in Title 12, Chapter 02 of the Alaska Administrative Code, dealing with occupational licensing fees for athletic trainers, a profession regulated directly by the Department, including the following:

12 AAC 02.395. Athletic trainers, is proposed to be changed to reduce the initial license and renewal fees for athletic trainers.

Under AS 08.01.065, the Department must establish fee levels so that the total amount of fees collected for an occupation approximately equals the actual regulatory costs for the occupation. The Department has reviewed the income and expenses for the occupational licensing program for the Athletic Trainers and proposes fee changes that reflect, to the extent possible, the actual costs of the activities related to the program.

You may comment on the proposed regulation changes, including the potential costs to private persons of complying with the proposed changes, by submitting written comments to Jun Maiquis, Regulations Specialist, Division of Corporations, Business and Professional Licensing, P.O. 
