2. Answers to Offeror-submitted questions are provided following the question submission deadline.
  1. **Question:** Section H, Proposal Content Requirements, paragraph 3.4, states: "Faculty and supervisors expect that the new software will be able to generate reports to assist them with monitoring day-to-day and fiscal year activity. Explain the types of reports that can be generated by the Phase 1 and Phase 2 software. However, the Scope of Work does not indicate the type of reports or detail level required for the ATC simulation software. Can you elaborate on this requirement?"

**Answer:** Reporting requirements shall be removed from this RFP's requirement. Vendors are welcome to include report types and/or detail in their proposals.
  2. **Question:** In our answer can we refer to any ERAM documentation or do we have to copy and paste every information needed?

**Answer:** Amendment Number Two (2) includes the ERAM documentation attachment. Vendors may refer to this attachment when developing their proposal.
  3. **Question:** What are the hardware specifications for all hardware being supplied by UAA?

**Answer:** The University will purchase hardware to meet the vendor's specifications.
  4. **Question:** What hardware will need replacement?

**Answer:** All hardware shall be purchased by the University to meet the specifications of the vendor. Any proprietary hardware required or offered by the vendor must be specified in the proposal and will be considered in the evaluation of that vendor.

5. **Question:** Could you specify the brand and model of the VSCS software that the supplied VSCS should look like?

**Answer:** The VSCS version should function identical to the VSCS utilized by students at the FAA Academy.

6. **Question:** Could the ERAM CBI's and lesson plans be provided?

**Answer:** Amendment Number Two (2) includes the ERAM documentation attachment. Lesson plans shall be provided to the successful offeror upon request
