ITB Documents, Clarifications and Questions:

1. Do you have estimated order quantities that you are able to provide for these items?

DOC RESPONSE: Yes, there are estimated order quantities in the ITB.

2. Do you have estimated order quantities by facility?

DOC RESPONSE: We do not as prisoner populations are always changing. This level of detail would be less accurate than the full estimate for the entire State and would take too much time and resources to keep up to date.

3. Are exceptions to the lead time stated in the bid allowed? Under the delivery section of the bid it indicates a required 45 day delivery, but in the case of custom items this may be longer.

DOC RESPONSE: Please refer to the Conditions section in the ITB, item #12. If the contractor is not able to fulfill a need for the State and the State must procure the item from another vendor, any extra costs associated with this may be billed back to the contractor.

4. Are vendors required to submit a bid for all line items or are partial bids being accepted?

DOC RESPONSE: Bidders must bid on every item within a lot to be considered responsive for that particular lot. There is no need to bid on all lots in the ITB to be considered responsive.

5. I also just wanted to confirm if an Alaska business license is mandatory to bid on this requirement?

DOC RESPONSE: No, unless you are applying for a preference. Note the section on preferences in the ITB.

6. I am just wondering if the sizes 66x104 and 90x54 are cut sizes or finished sizes?

DOC RESPONSE: We only purchase finished goods.

7. Regarding the laundry bags, it does not specify in the RFQ if regular laundry bags or mesh bags are needed. Can you please advise?

DOC RESPONSE: We are looking for regular laundry bags.

8. Just wondering if the below fabric is an acceptable substitute for the items in Lot Two (2) – Item # 1 & 2.
(Muslin 45% polyester 55% cotton blend, 130 thread count) - 152 thread count, 50% cotton/50% polyester

DOC RESPONSE: Yes, it is acceptable.

9. Would you be able to provide more details on the 100% polyester flame retardant fabric in item # 3 in the same lot? We would need oz./per sq. yard and more construction details.
