The Department of Law has reviewed the attached regulations of the Department of Commerce, Community & Economic Development against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Commerce, Community & Economic Development after the close of the public comment period. The regulations concern occupational licensing fees for electrical administrators.

The May 24, 2019, public notice and the July 9, 2019, adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

**NOTICE OF PROPOSED CHANGES TO OCCUPATIONAL LICENSING FEES FOR

**BRIEF DESCRIPTION:** The Department of Commerce, Community, and Economic Development proposes to change occupational license fees charged to electrical administrators.

The Department of Commerce, Community, and Economic Development (Department) proposes to adopt regulation changes in Title 12, Chapter 02 of the Alaska Administrative Code, dealing with occupational licensing fees for electrical administrators, including the following:

**12 AAC 02.210, Electrical administrators**, is proposed to be changed to alter the nonrefundable application fee, the biennial license and renewal fees for electrical administrators, and repeal the electrical administrator examination fee.

Under AS 08.01.065, the Department must establish fee levels so that the total amount of fees collected for an occupation approximately equals the actual regulatory costs for the occupation. The Department has reviewed the income and expenses for the occupational licensing programs mentioned above and proposes fee changes that reflect, to the extent possible, the actual costs of the activities under these occupational licensing programs.

You may comment on the proposed regulation changes, including the potential costs to private persons of complying with the proposed changes, by submitting written comments to Sher Zinn, Regulations Specialist, Division of Corporations, Business and Professional Licensing, P.O. Box 110806, Juneau, AK 99811-0806. 
