The space shall be within an approximate one point five (1.5) mile radius of the new State Courthouse located at 306 W 5th Avenue, 99762, and shall include the following special features: 6 private offices, 2 hard cells, meeting rooms, a private entrance outfitted with bullet resistant glass/walls, a dedicated UA restroom and a dedicated restroom within the space for staff in addition to standard public access restrooms. Signed parking for 2 State owned vehicles and 8 additional spaces for employee vehicles is required. Onsite parking is preferred but shall not be further than within 750 feet of the main entrance to the proposed office location. The State will consider a firm term lease of approximately 5-years with additional renewal periods up to 10 years. The projected occupancy date is July 1, 2020.

The State is considering all alternative space where economically advantageous. The State will use the information it receives in response to this advertisement as the basis to develop a cost/benefit analysis and to determine whether to compete this office lease space requirement or take other appropriate action.
