Notice of Utility Tariff Filing

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Waste Connections of Alaska, Inc. d/b/a Alaska Waste (WCA) has filed TA127-692, a revenue requirement, cost of service, and rate design study, for its residential service, based on a 2018 test year. With this filing, WCA is proposing permanent rate changes, based on the outcome of the included cost of service/rate design study. If the Commission suspends the filing, WCA proposes an interim and refundable across-the-board rate increase of 3 percent, effective February 28, 2020. In addition, WCA proposes the following changes to its tariff:

- Remove Martin Luther King Day, President's Day, and the day after Thanksgiving Day as holidays observed by the utility;
- Add a new definition for secure trash regulation zone;
- Add a new definition for a wildlife surcharge and introduce a wildlife surcharge;
- To limit the amount of time that credit will be given for the suspension of service due to vacation to not exceed 2 months:
- Remove the rates for standard can service, which has been phased out;
- Introduce a 64 gallon bear cart;
- Introduce a new zone (Zone 4) for the secure trash regulation zone and a wildlife secure trash credit for Zone 4;
- To reduce a disposal surcharge to \$0.00 when a permanent rate increase is approved;
- To increase some of its non-recurring charges; and,
- · Add monthly charges for additional bear carts.

The sample of the current and proposed rates and non-recurring charges are shown in the table below:

WCA filed a request for waiver of the requirements of 3 AAC 48.275(a)(8), 3 AAC 48.275(a)(9), 3 AAC 48.275(a)(11), 3 AAC 48.275(a)(12), and 3 AAC 48.275(a)(13), requiring pro forma schedules of provision for income taxes, computation of rate base using a 13-month average, cash working capital, computation of weighted cost of capital, and a schedule of long-term debt, respectively. Finally, WCA proposes to subsidize Alaska Waste's Interior and Kenai service areas from WCA and Alaska Waste Mat-Su to slightly lower rates in Interior and keep rates at current levels in Kenai.

This notice does not contain all requested revisions and the Commission may approve a rate or classification which varies from that proposed.
