12 AAC 02.215 is amended to read:

**12 AAC 02.215. Euthanasia of domestic animals.** The following fees are established for agencies that purchase, possess, and use certain drugs to euthanize domestic animals:

- (1) **nonrefundable** application fee for initial euthanasia permit, **\$100** [\$25];
- (2) permit fee for all or part of the initial biennial license period, **\$300** [\$25];
- (3) biennial permit renewal fee, **\$300** [\$25]. (Eff. 11/15/2002, Register 164; am 6/17/2005, Register 174; am 6/9/2007, Register 182; am 6/28/2009, Register 190; am 5/15/2013, Register 206; am 3 / 5 / 2020, Register 233 )

The Department of Law has reviewed the attached regulations of the Department of Commerce, Community, and Economic Development against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Commerce, Community, and Economic Development after the close of the public comment period. The regulations concern permit fees for agencies that purchase, possess, and use certain drugs to euthanize domestic animals. The department directly regulates those agencies under AS 08.02.050.

The August 29, 2019 public notice and the January 23, 2020 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

We have made a technical correction to the footer of the regulations in accordance with AS 44.62.125. The edit is shown on the attached copy of the regulations. We have made no edits to the regulations themselves.

**NOTICE OF PROPOSED CHANGES TO OCCUPATIONAL LICENSING FEES FOR  
EUTHANASIA OF DOMESTIC ANIMALS IN THE REGULATIONS OF THE  
DEPARTMENT OF COMMERCE, COMMUNITY, AND ECONOMIC DEVELOPMENT**

**BRIEF DESCRIPTION:** The Department of Commerce, Community, and Economic Development proposes to change occupational license fees charged to occupations relating to euthanasia of domestic animals.

The Department of Commerce, Community, and Economic Development (Department) proposes to adopt regulation changes in Title 12, Chapter 02 of the Alaska Administrative Code, dealing with occupational licensing fees for euthanasia of domestic animals, a profession regulated directly by the Department, including the following:

**12 AAC 02.215. Euthanasia of domestic animals**, is proposed to be changed to alter the application, permit, and renewal fees for agencies that purchase, possess, and use certain drugs to euthanize domestic animals.

Under AS 08.01.065, the Department must establish fee levels so that the total amount of fees collected for an occupation approximately equals the actual regulatory costs for the occupation. The Department has reviewed the income and expenses for the occupational licensing program for the Euthanasia of Domestic Animals and proposes fee changes that reflect, to the extent possible, the actual costs of the activities related to the program.

You may comment on the proposed regulation changes, including the potential costs to private persons of complying with the proposed changes, by submitting written comments to Jun Maiquis, Regulations Specialist, Division of Corporations, Business and Professional Licensing, P.O. Box 110806, Juneau, AK 99811-0806. 
