ITB TITLE: Contract for the purchase of miscellaneous laundry, warewashing, janitorial chemicals, paper, plastic, and toiletries

Amendment five (5) forms a part of the ITB documents and provides answers, clarifications and modification to the ITB requirements. All other items remain the same.

1) VENDOR QUESTION: Are you able to extend the deadline for bid submission?

DOC ANSWER: Yes.

ITB OPENING DATE AND TIME has changed from February 14th, 2020 prior to 2:00PM Alaska Standard Time to Feb 21st, 2020 prior to 2:00PM Alaska Standard Time.

2) VENDOR STATEMENT: Dispensers for janitorial chemicals that measure chemical concentrations are not available at this time and would be prohibitively expensive to implement.

DOC ANSWER:

As a result of changing the ITB opening date and time, the details regarding bimonthly report submission must be modified. In addition, ITB condition #44 requires a modification to remove language regarding janitorial chemical dispensers. For these reasons, delete ITB condition #44 in its entirety and replace with the following:

ITB Condition #44

44. REQUIRED REPORTS: *The contractor(s) shall also furnish the State with quarterly reports during the term of the contract and any extension periods. Reports shall be submitted to the Contracting Officer within thirty (30) days of the end of the quarter.*

- * *Second Quarter Report Due: June 30*
- * *Third Quarter Report Due: September 30*
- * *Fourth Quarter Report Due: December 31*

Reports shall list for each facility the total quantity and dollar volume of each contract line item purchased under any contract resulting from this bid.

The contractor(s) shall also furnish the State with bimonthly reports during the term of the contract and any extension periods. Reports shall be submitted to the Contracting Officer within thirty (30) days of the end of every second month. Reports will begin to be received starting May 1st (For the period of March 9th to April 30th) and continuing July 1st (for May 1st to June 30th), and so on. These reports shall list each laundry and warewashing machine (by facility), how many loads or racks were cleaned, what setting the machines were on, and the chemical concentration that was used. These reports must show the history of every load for the two-month period. Reports shall also list the amount of janitorial chemicals that were consumed for the two-month period.

- 3) **VENDOR STATEMENT:** Current dispensers for janitorial equipment do not measure the amount of chemical that comes out when the button is pressed. It would be prohibitively expensive to use janitorial chemical dispensers that release a pre-determined amount of chemical based on what the container size was, as well as to use higher technology dispensers that log usage or create reports.

DOC ANSWER:

As a result of this information, delete ITB condition #56 in its entirety and replace with the following:

ITB Condition #56

56. DISPENSING EQUIPMENT: *All specified dispensers and related equipment shall be delivered, installed, and if required, removed at no additional cost to the State, on the units listed herein. Each facility (and any facility added to this contract in the future) reserves the right to require the contractor to install additional equipment should circumstances or volume of business warrant, or when additional/new machines are installed.*

The dispensing units will remain the property of the contractor. Parts books and maintenance manuals must be provided at the same time the equipment is delivered. There will be no additional cost for parts books or maintenance manual.

All arrangements for delivery and installation shall be made within ten (10) days after receipt of a Delivery Order unless a delay is requested by an individual facility. Arrangements are to be made at each facility with the designated agency contact person listed on the Delivery Order.

If there is currently equipment installed at a particular facility that does not belong to the successful bidder, the successful bidder will coordinate with the facility and the previous contractor to ensure equipment installation is done to assure the facility can function with uninterrupted service.

Dispensers for the laundry and warewashing shall have the capability to automatically dispense different concentrations of detergents and related chemicals based upon what cycle the washing machines are set to. These dispensers shall also have the ability to log which cycle is chosen for every load, how much chemical is dispensed per load, and how many total loads or racks have been washed.

- 4) **VENDOR QUESTION:** For outlying areas such as Nome and Bethel, if they require unscheduled service who will be responsible for airfare costs?

DOC ANSWER: *The vendor will be responsible for airfare if the unscheduled service is a result of faulty equipment or inadequate preventative maintenance.*

On page 14 of the ITB document, delete Service Schedule paragraphs in their entirety and replace with the following:

Service Schedule:

The successful bidder shall supply, at no additional cost to the State, adequate experienced personnel capable of and devoted to providing effective and efficient service as required to accomplish the requirements specified in this ITB.

** Service shall be provided at least once every 90 days at all Department of Corrections' facilities located within the Anchorage area (including Eagle River, Palmer, Sutton, Kenai, Wasilla and Seward), Fairbanks and Juneau. At no extra cost, individual facilities may set their own requirements for more frequent service arrangements (weekly, bimonthly, etc.).*

Service for facilities located in outlying areas (Nome, Bethel and Ketchikan) shall be provided at least once every 120 days and the costs associated with these regular scheduled maintenance visits is to be included in the price of products purchased. Should it be necessary for these outlying facilities to place unscheduled service calls the contractor will be allowed to bill for actual airfare costs if the emergency service is determined to be a responsibility of the inmates or of the state. If the emergency service is a result of faulty equipment or inadequate preventative maintenance, then the contractor will pay for their own airfare to fix the problem. The contractor must provide adequate evidence of damage and the determination of fault will be at the sole discretion of the state. To receive reimbursement the contractor must submit a copy of the airfare ticket with their invoice. No charges other than coach class airfare will be reimbursed.

- Line Item 21: Description says Plastic bowls and Foam - I assume it is Foam based on the Dart 6SJ12
- Line Item 22: Description says Plastic bowls and Foam - I assume it is Foam based on the Dart 12BWWCR

- 6) **VENDOR QUESTION:** For outlying area such as Nome and Bethel that receive goods by a barge on a limited schedule, who will pay for shipping if they need a shipment by air?

DOC ANSWER: Delete ITB condition #24 in its entirety and replace with the following:

24. **SHIPPING COST:** The cost of shipping and delivery to the final destination shall be included in the bid price. There will be no additional charges for shipping, handling, or delivery upon receipt of goods.

Standard procedure shall be to ship annual quantities during the barge season for outlying institutions such as in Nome and Bethel (AK). Shipping costs shall be included in the bid for this standard procedure. If these institutions require alternative shipping outside of barge season (such as by air), shipping costs may be billed to the institutions as actual costs with no additional fees.

- 7) **DOC CLARIFICATION:** Delete 2020-2000-4338 Bid Schedule instruction #7 in its entirety and replace with the following:

Pricing for solid detergents versus liquid detergents

In the bid schedule there is the option to provide a solid detergent or liquid detergent for each washing machine (laundry and warewashing). There is also the option to offer both solid and liquid for each machine. The bid schedule will automatically choose the least expensive option. If

the machine is already set up to use the more expensive option, the vendor shall provide fully automated dispensers for the less expensive product.

- 8) **VENDOR QUESTION:** Was the last awarded bid for these items released to the public? If so, would you be able to direct me on where to find that information?

DOC ANSWER: Yes. See attached copy of the last contract titled DOC 154. Tables on pages #10 to #17 show the pricing.

- 9) **VENDOR QUESTION:** Would you be able to provide me an unprotected version of the excel. The protected version will be used for the submission but we would like to use the excel to build in our cost, item number, etc so that we can work on it internally. We are not able to do that with the locked version.

DOC ANSWER: If I send it to you, I have to make it public. I can't do that because then it'll take a lot of work to ensure that contractors have not manipulated the formulae to their own advantage. There are too many variables involved.

If you explain in greater detail why you want this I may be able to offer some compromise.

VENDOR RESPONSE: I understand. I was just looking for the ability to copy and past columns(A,B,C,D) onto a new excel so that we can create an internal working copy to ensure we have the right item, cost, price, etc before transferring it to the final submission. Most excels are locked down for the formulas and adding additional columns, this one seems to be locked down everywhere and doesn't allow for the ability to copy/paste

DOC ANSWER: DOC is posting the unlocked version of ITB 2020-2000-4338 Bid Schedule with only the descriptive columns in an Excel format on the Online Public Notices website and this document is incorporated by reference in amendment #5.

- 10) **VENDOR QUESTION:** Thanks for the addendum. Ecolab does have a question regarding the spec on the first 2 lines of the Warewashing Lot:

RE: Chlorinated Warewashing Detergent

Recent innovation has eliminated the need for Chlorine in Warewashing detergents. This innovation is better for the environment and meets regulatory standards across the country. Please consider removing Chlorinated from the spec for lines 2.1 & 2.2.

Thank-you for your consideration.

- *The product shall be a non-abrasive cleaning material specifically formulated for use as silverware pre-soak and for de-tarnishing silver and stainless steel tableware.*
- *The product shall contain activators to soften and remove hard set or baked on food from all types of utensils and surfaces.*
- *The product shall contain wetting agents that rapidly penetrate and soften food soils.*
- *The product shall be of a free-flowing powder or granular type.*
- *The product shall be formulated to neutralize food acids and chlorides, and to prevent corrosion of stainless steel surfaces while halting corrosion already present.*
- *The product shall have the ability to de-tarnish in warm to cool water, eliminating the need for very hot water.*
- *Container size shall not exceed ten (10) pounds.*

12) **DOC CHANGE:** *Considering the specification modifications to the item numbers in Lots #4 and #5, and the change in instruction #7 in the Bid Schedule, delete 2020-2000-4338 Bid Schedule in its entirety and replace with 2020-2000-4338 Bid Schedule Amendment #5. This new bid schedule will be uploaded to the Online Public Notices website and must be used for bid submission.*
