ITB TITLE: Contract for the purchase of miscellaneous laundry, warewashing, janitorial chemicals, paper, plastic, and toiletries

This amendment forms a part of the ITB document and provides answers, clarifications and modification to the ITB requirements. All other items remain the same.

1) VENDOR QUESTION:

How would you like me to enter the information for those locations? Should I leave the sanitizer listed or not?

DOC RESPONSE:

Consider all loads to be hot loads not using sanitizer, but still list a price for it in the specifications sheet. I will assume 110 gallons of annual estimated consumption and add that to the bid abstract separately for the total cost of the warewashing. If you have any questions about this, please let me know and I will clarify.

2) VENDOR QUESTION:

Could you adjust the formula for the janitorial chemicals to factor in the dilution rate?

DOC ANSWER: Yes, it is done.

3) VENDOR QUESTION:

I do have a follow up on this, how the sanitizer will be chosen?

If the Solid Dish Machine Detergent & Solid Rinse are chosen as most cost effective option for the state – since the Sanitizer is separated out, will the most cost effective sanitizer be chosen regardless of solid/liquid form?

DOC ANSWER:

Yes, the most cost-effective sanitizer will be chosen.

4) DOC STATEMENT:

As a result of these latest requests, the ITB 2020-2000-4338 Bid Schedule Amendment #6 shall be deleted in its entirety and replaced with 2020-2000-4338 Bid Schedule Amendment #7. Take special note of the Summary worksheet as there is now a required input for the dilution rate of the dish sanitizer.
