THE DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES


The attached five pages of regulations, dealing with commercial vehicle compliance, are adopted and certified to be a correct copy of the regulation changes that the Department of Transportation and Public Facilities adopts under the authority of AS 19.05.010, 19.05.020, 19.05.040; AS 19.10.060, 19.10.310, 19.10.340, 19.10.370; AS 44.42.020 and 44.42.030 and after compliance with the Administrative Procedure Act (AS 44.62), specifically including notice under AS 44.62.190 and 44.62.200 and opportunity for public comment under AS 44.62.210.

This action is not expected to require an increased appropriation.

Although no public comments were received, the Department of Transportation and Public Facilities paid special attention to the cost to private persons of the regulatory action being taken.

The regulation changes adopted under this order take effect on the 30th day after they have been filed by the lieutenant governor, as provided in AS 44.62.180.

The Department of Law has reviewed the attached regulations of the Department of Transportation and Public Facilities against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Transportation and Public Facilities after the close of the public comment period. The regulations concern commercial vehicle compliance, the adoption by reference of updated federal regulations, and the adoption by reference of the department's updated February 2019 *Administrative Permit Manual: Oversize and Overweight Permits*.

The November 18, 2019 public notice and the February 21, 2020 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.





17 AAC 25.210, which adopts by reference federal regulations pertaining to the safe operation of commercial motor vehicles, is proposed to be changed to adopt the October 1, 2018, version of those regulations, and to make minor changes in wording to conform to the language in federal commercial passenger vehicle regulations.

17 AAC 25.220, which adopts by reference federal regulations pertaining to the hours of service for commercial vehicle drivers, is proposed to be changed to adopt the October 1, 2018, version of those regulations.

17 AAC 25.320, which pertains to permits for oversize or overweight vehicles, including adoption by reference of the Department's Administrative Permit Manual: Oversize and Overweight Permits, is proposed to be changed by adopting the February 2019 version of this manual.
