## **Chapter 80. Fees for Department Services.**

## 7 AAC 80.030. Fee schedule and procedures.

7 AAC 80.030 is amended by adding a new subsection to read:

(f) The department will calculate and charge an administrative fee for each contract. The amount of the fee will be an amount equal to five percent of the total contract value for each participant in the Alaska SHARP-1 state health care practitioner loan repayment program under the Public Health Service Act, Title III, Section 338I(a)-(i) (42 U.S.C. 254q-1(a)-(i)).

7 AAC 80.030 is amended by adding a new subsection to read:

(g) The department may charge an additional fee for each contract if the department contracts for fiscal agent services. The amount of the fee will be an amount equal to one and one-half percent of the total contract value for each participant in the Alaska SHARP-1 state health care practitioner loan repayment program under the Public Health Service Act, Title III, Section 338I(a)-(i) (42 U.S.C. 254q-1(a)-(i)).
